My dear Doctor:

Following my night letter of yesterday I want to confirm the indefinite postponement of all district conferences owing to the ruling of the State Board of Health in closing all public meetings. I have had a conference with the Governor and his Secretary and have the assurance that the moment there is any liklihood of the lifting of the ban I shall be informed in order that I may make my plans and if there is time arrange for the conferences immediately. We have our team all ready and can arrange to begin our conferences the day following the opening of public meetings and such.

I am sending out a special bulletin to every representative throughout the state informing them of this action, and urging them to commence the beginning of the week to intensify their organization down through the county in every community, including the remotest school district. Mr. Witham will be on the ground the beginning of the week. He will immediately commence his organization. The moment he is on the ground I shall call the various county representatives to a meeting in Moscow to talk the final apportionment of the quotas over and our method of organization and education throughout the counties.

I hope you will have whatever material is forwarded to Mr. Witham taken care of carefully until his arrival.

I just received from National Headquarters today samples of the bulletins for the county organization. I never saw such a complete and inclusive pamphlet along this line. The advertising material is wonderful and I shall look for a general feeling of enthusiasm the moment our publicity is released.
