

Arboretum Newsletter, Spring, 1980

You are cordially invited to attend the annual meeting of the Arboretum Associates, Thursday, April 24, 1980, 7:30 pm, at the University of Idaho Student Union Building. The room will be posted at the Information Desk. In addition to routine business, there will be a presentation-status report on the addition to the Shattuck Arboretum. Copies of the completed Master Plan will be available for review. Will you join us for this annual meeting?

The University of Idaho Foundation, Inc. has received a Comprehensive Education Training Act (CETA) grant for \$18,500 to be used for the arboretum during 1980. Shelter belt planting, pest control, and the planting and maintenance of a display garden will be undertaken soon, as the new Shattuck Arboretum and Botanic Garden work commences.

Earth moving for stabilization of the east slope of the ASUI-UI Golf Course, adjacent to the arboretum site, has been completed, according to Ernest W. Hartung, Executive Director, University of Idaho Foundation, Inc.

The Alpha Phi Sorority at the UI was the first Life Associate Member of the Arboretum Associates. Donations from alumnae, members, and friends of Alpha Phi enabled this membership in association with Alpha Phi's 50th anniversary. THANK YOU, Alpha Phi!

During Fall Semester, 1979, the UI Faculty Women's Club held a silent auction to benefit the Arboretum Associates. Under the direction of Marlene Johnston, the auction netted \$220 for the Arboretum Associates. Special thanks are due to all of those who contributed items for this sale, and to those who purchased items.

Daryl Ann Brown, junior student majoring in Art-Design, won the \$100 prize offered by Arboretum Associates for the design of a logo, letter-head, and related materials. Her winning design, used here for the first time, will serve as our "trademark" for years to come. Daryl, who came to the UI from Worley, Idaho, was one of the many competing students enrolled in Jim Engelhardt's Advanced Graphic Design class, Fall Semester, 1979.

The Shattuck Arboretum and Botanic Garden Master Plan has been completed by Richard Carothers Associates of Boise, Seattle, and Portland, under the Direction of Don Belts, Boise. Copies of the Master Plan may be viewed at the University of Idaho Foundation, Inc. office, Room 104, UI Administration Building. One copy, available for one day checkout, may be obtained from the Closed Reserve Room in the basement of the UI Library.

The Shattuck Arboretum project is formally associated with three groups, each with specific missions and limits of activities. Here is a brief outline of the activities of the three groups.

University of Idaho Foundation, Inc., Ernest W. Hartung, Executive Director: Solicitation of funds and grants from trusts, granting agencies, and private individuals who can make trust agreements with the University of Idaho; making contracts for the University of Idaho; presentation of copies of the Master Plan of the arboretum to agencies and trustees of various funds; making contracts with engineering and architectural firms, landscape architects, etc.

University of Idaho Campus Arboretum Committee. The committee, originally named by former President Ernest W. Hartung, is to oversee the specific implementation of the Master Plan and the daily operations of the arboretum as the project commences. Specific changes in the Master Plan are the responsibility and province of the UI Campus Arboretum Committee. The committee consists of members of specific academic departments which have direct interests in the arboretum, and of specific other University officials. At present, the committee consists of:
