MESSAGE FROM THE ARBORETUM ASSOCIATES' PRESIDENT

The Constitution for the Arboretum Associates requires that proposed amendments thereto be distributed to all members not less than four weeks prior to a general membership meeting. The Constitution also requires that changes to the Bylaws of the Arboretum Associates be ratified by the general membership. The annual membership meeting is scheduled for 7:30 p.m., April 20, 1993, at the U of I Golf Course Restaurant (19th hole). At that time, the membership will be asked to approve or disapprove the following amendments to the Constitution and the Bylaws (proposed deletions are ~~ed~~ out and proposed additions are underlined):

AMENDMENTS TO THE CONSTITUTION

ARTICLE II

PURPOSE

The Arboretum Associates is organized to further the development of, and interest in, the University of Idaho Arboretum (~~Shattuck Arboretum~~) and Botanical Garden and to disseminate information about, and from, the said Arboretum and Botanical Garden.

ARTICLE IV

ORGANIZATION - OFFICERS

b. Executive Committee - Ongoing business of the organization shall be conducted by an executive committee consisting of the officers and three members at large elected from the general membership to staggered three year terms. A member at large may serve for two consecutive terms but may not be reelected thereafter until four years have elapsed. The University of Idaho Arboretum Director of the ~~Shattuck Arboretum~~ shall be an ex officio, nonvoting member of this committee.

SECTION 2. DISTRIBUTION OF FUNDS

At the discretion of the Board of Directors, all money shall be: 1) deposited in a local bank with any reserve funds to be deposited in an interest bearing account as authorized by the Board of Directors, or 2) deposited with the University of Idaho Foundation, Inc. in accounts designated for the benefit of the Arboretum Associates and/or the Shattuck Arboretum Phase II University of Idaho Arboretum and Botanical Garden.

SECTION 3. BILLS TREASURER

~~All bills in excess of \$100.00 are to be approved by the Board of Directors before being paid. Two officers' signatures are to be used on checks if the Board of Directors is expending funds from a bank account that is not in the name of the University of Idaho Foundation, Inc.~~ The Treasurer, or designate, shall collect and administer all gifts and other funds as directed by the Board of Directors in accordance with generally accepted accounting principles and state and federal laws.

SECTION 4. BOARD OF DIRECTORS

The Board of Directors is composed of the Executive Committee (elected officers and members at large) and the heads of each of the standing committees. ~~The Director of the Shattuck Arboretum University of Idaho Arboretum Director~~ shall be an ex officio, nonvoting member of the Board of Directors. It Said Directors shall meet at least quarterly as per the Constitution, or on call by phone at least five days in advance. Directors will receive at least five days written or telephone notice in advance of a meeting. The call Said meeting notice can be made transmitted by the president or any two members of the board.

SECTION 5. COMMITTEES

At the discretion of the Board of Directors, Standing committees may include membership, finance, special grants, publications, and nominations. Special committees shall be appointed as needed.

SECTION 7. HISTORICAL

The University of Idaho Library Special Collections shall be the depository for all Arboretum Associates archives.

SECTION 8. DISSOLUTION

Upon dissolution of this organization, any money or property shall be given in trust to the University of Idaho Foundation, Moscow, Idaho, for ~~use of the Arboretum~~ addition to the principal balance of the Arboretum Associates Centennial Endowment.

SECTION 9. RESIGNATION OTHER

~~If anyone resigns before his/her term is completed~~ Should an officer or member of the Board of Directors resign or otherwise be unable to complete his/her term of office, the president can appoint a person to fill the position with subject to the approval of two-thirds of the members of the Executive Committee.

SECTION 10. AMENDMENT

The Bylaws may be amended by a two-thirds vote of the Board of Directors present at any duly called quarterly or special meeting of the Directors. All amendments must be ratified by the general membership in accordance with the Constitution.

Winter 1992-93 Update

I greatly appreciate the compliance with the ban on downhill snow recreation in the Arboretum this winter of 1992-93. During my "walkabout" in the new Arboretum Saturday, February 13, I observed minimal human-inflicted damage to our plantings. I am grateful for the efforts of neighbors, friends, the Moscow Police Department, the Argonaut, the Daily News, and Cablevision Channel 28 for their unstinting assistance in educating members of the community about our new Arboretum. Thank you all!

Due to the close mowing of the last year, rodent control efforts, metal tree and shrub collars, and the local raptors, it appears that we have had little chewing and girdling damage by meadow voles and pocket gophers in the Arboretum as of February 13, 1993.

Unless we have significant freeze damage between now and May 15, we should have some spectacular shows of crabapple and lilac flowers this spring. The majority of plants in the Idaho State Federation of Garden Clubs' Constitutional Grove of European Lilacs should flower this spring. In addition, many Asian Lilacs in the Linda Kinney Hollenbeck Grove should flower this year.
