Ifartin Pisher was shot in the baok of the head and killad at Gows Tdaho, ADrid 14th 2901, has body was found lying on the sidewadk in frant of Dan Marringtons Saloon.

Opro made the acquatntance of Dan Farrington, and during the oome vergetion wa had oonoerting the Biaher murder he bad thet, the faloon was olosed (Haning the (oor) when the shot was stred, he satd that he saw the Shash of the give through the window but no one went, out, until San Pindey and one other man owan in tem manutes 3ator, on entering tho sploon jand y saked Harrington, if any one had come in or vent out of the Saloong and Was told by Rarrinctons, thst no one had ome in or went out ainoe the shot was firen Plndey then loft the Saloon followed by Bevornl others whe were in the galoon when the shot way stred.

Opr. saked Harrington is ho knew Fishor very weld and he aadd that he did and that ho way on quiot nioe man. ODr, anked Harrington why my ona Bhould want to kill ham, Bnd he sald that Sem 3 inley the Dopisty had ordered hate out of tom some time before.

Opr. askad what that had to do with the killing of Pishar, and ha said When yous are hore an long si I have been you will 2marn not to say to mucho

keliling, छut oould not draw him out any more ooncering the wattor at thds Interyiot.

Opr. xama a through investigation of Harringtons promiges and found that there was ne way to get up stedrs. exoent by the means of a dadder and that there is only a smali atic or space above the Saloon, whioh has
a window faoing on the street, Opr, found out that the window does not open and that it would be irapossible tc take it out, without being seen or heard by the Saloon below, Opr, made a through investigation of the side walk in front of Harringions place where Fishers body fell, and is of the opinion that it would be impossible for Sam Finley to have fired the shot that killed Fisher from the pusition the body laid in, the direction in whioh the bail passed thiough Fishers head, and the position that Pinley was discovered in when first observed near the body $7 s$ he was at that time and must have been a sew rainutes prior to the time the shot was firad, at a lower elevation on the sidewalk, making it imposaible far him to fire a shot taking a downward course through Fishers head.

Opr, learned that Sam Finley had been drinking, and was intoxieated at the time

From Ao W. Myers Opre learned that the wound in Fishers head was made by a large Calbre, soft nozed bullet.

In looking up the whereabout 3 of Artiur Wallaos on the night of the killing, Opfo learned that he was at Gem and thas at about fifteen minutes difer the shooting he oame down the strest from the direction of the Frisco Mine, where he had bsen visiting a Mrs Robertson that evening, on arriving at the point where Fisher had been killed he asked John Wan, What was the matter, Wan told him that some one had killed Pisher, and that some of the boys say that Sam Finley was on the atreet at that time and may have had trouble with him, Wallaoe thon went to Henry Connelys Saloon where he remained for about five minutes when he went up stairs.

Opr, learned that there were several. old timers on the stroet and in the vioinity of Dan Harringtons Saloon at the time of the killing, but as soon as it was reported thet Finley had shot Figher, they all went home claiming that they were arraid that they might get mixed up in it.

Fallace, Idaho, May 26, 1901.
Opr. reports:
That he was sitting in the office of the सathaway Rooming House, when Catharine Kaine remarked, there goes Arohie Granahan XXX G, Opr looked across the street and saw a man 38 to 40 yerrs old 5it. 10 inches high, 165 lbs, dark complexion, dark sandy mustche, sharp features, darle olothes saok coat.

Miss Kaine said that the day "Kneebone" (s blaoksmith at Gem Mine shortly after the siorile in 1892) was killed, that she and her naioe Loretta Kaine were walking down the raileroad traok, when they met a orowd of masked mon, and that she noticed that her brother Will Kaine was among them, and that she watohed them and that they went aoross the oreak and approached some men near the jinine, and that all or thom gave up to the masked men exoept "Kneeboies", who went towards hia cabln, and that she saw Granaian and Killdee (who was killed at Gem last fall by Diok Admans) raise thei: guns and Iirs, and Eaw "Kneebones" Pall, and that later Granahan came to hor home with har brother Will Kaine and unmasked, that at the time she was not sure about Killdee but later leamed it was $\mathrm{him}_{\text {o }}$

Opr. got on to the street as soon as possible and sam Granahan get on a Nowihern Paoific train for Gem, but did not get an opportunity to talk with him, Opr, observed Granahan shake hands with Bili Baxton, and heard him say that he was going to gem at $3: 45 \mathrm{P}, \mathrm{M}$ 。

Long Shorty (Gant) of the firm of Sweet and Gant, told Oprs that he and his partner had no leve for the Deputies, but it was business on their part to treat them nice', as they blowed their money and he might as well have it as any one elso.

A Spokano, Swede Gambler (who runs a poker game at Fred Steers place) says that the men who are keeping this country down (Meaning Mine Mgin and. Deputies) should be blown to Hell.
