"One of the primary aims of the FSA program is to enable borrowers to produce practically all their food supplies as well as livestock feed on the farm so that their cash expenditures for such items will be reduced to the minimum," Duffy said.

Full repayment of loans has been made by 590 families and 79.1 per cent of maturities due when met.

Another measure of progress of these families, Duffy said, is that nearly 670 children of school age in these borrowing families have been enabled as a direct of the FSA program.
