COURT REVOKES PAROLE OF LOWELL "CASEY" COONROD

Lowell "Casey" Coonrod was returned to the state penitentiary Saturday, following a court hearing in which his pardon was revoked. He was committed to the institution for from 1 to 15 years.

Coonrod's former conviction was on a burglary charge, but he was paroled. In the last instance the state asked that the parole be revoked because of a conviction of petit larceny in Blaine county on September 24 of this year.

Coonrod contended that he was not guilty of the charge, but he had previously been convicted of it at a trial held in that county.

Fire Loss Small This Season In Payette Forest

The fire season, in so far as the Payette National Forest is concerned, has been quite satisfactory this year, according to J. O. Stewart, forest supervisor.

Mr. Stewart said that there had been exactly 100 fires to-date in this district, all of them small. The largest fire of the season was that on Norton Ridge in the Middle Fork Salmon country, and that fire was only 8 acres in scope. The total fire damage in the district was less than \$100, which is quite low compared with previous years.

Lookouts were called in on October 15th, following the heavy rain. Road crews likewise have all been called in with the exception of Bert Thayne and his crew of men who are maintaining the Cascade-Knox road. The principal activity of the service right now is burning brush and slashing.

Supervisor Stewart attributes the small fire damage to the late rains, which were heavy up until June 29 and which kept the vegetation green well into August. Likewise a great deal of credit must go to the guards who were vigilant and alert thruout the season.

This winter there will be two CCC camps in the Payette National Forest, one at Gallagher ranger station and one at the middle fork of the Payette river above Garden Valley.

During the last few years there has been but one camp in the reserve, it being stationed at Gallagher in the winter and at Warm Lake in the summer. The camp last winter and summer was composed of a company of Missouri boys, but on October 15 they were replaced by a company from New York. A New York company is also located at the Garden Valley camp.

During this coming winter the Gallagher camp will be largely occupied with the construction of the Banks to Lowman road, while the Garden Valley camp will concentrate on improving the road of the middle fork of the Payette river and reconstructing the Cascade-Garden Valley telephone line.

Regular employees of the forest service, stationed in Cascade this winter will consist of two rangers, one warehouse man and two mechanics.

Mr. Stewart assumed the supervision of the Payette National Forest in June, coming here from Wyoming. His district encompasses 1,200,000 acres, most of which lies within Valley county.
