Referring to boiler contract, we neglected to ask you the exact pressure for which you wish safety valve set to correspond with that setting carried on your old boilers. We would appreciate a note from you with regard to this.

It has also occurred to jus that you might desire. in addition to the extra work outlined on page 6 of contract, at the same time to take down the stack on the Hawkes Boiler and install foundations. We could handle all this work for you on the basis of cost plus 10% and make possible the expeditious handling of this work without interferring with the routine work of your organization. From the writer's observations we would gather that you have a well knit organization to take care of ordinary work but are not sufficiently organized to handle extra work of this sort without possible interference with your daily routine. With this in mind we believe we could come in on to the job earlier than we would ordinarily appear for the simple erection of boiler as covered by contract, and handle this work for you on the above basis and at the same time save you the

amount of our fee for such handling. If you think well of this procedure we would like to know sufficiently in advance so that we may take such steps as may be necessary to serve you to best advantage.

We have written our Works at Barberton asking them to sendyou copy of drawing No. D-2735 covering the boiler as originally set, also copy of drawing No. PSD-7919 showing suggestion made in 1920 for improvement of furnace. We will have them make up a new drawing showing the further improvement of furnace to correspond with suggestions made by the writer.
