Referring to boiler drawing sent you some days ago, we would like to hear from you, sending any comments in connection with this installation. We note from sketch of feed hole tile that you are furnishing, that these tile are 18 inches long. If the boilers are installed as shown on Babcock & Wilcox drawing with the considerable depth between crown of the arch and top of furnace deck, it will be necessary to put two of these feed holes, one above the other, to reach from crown of arch to top of deck. As referred to in our letter of the 11th, we are wondering whether you did not wish to cut down the deck height of these ovens so as to make a shorter distance between crown of arch and top of deck.

According to the latest information, boiler was supposed to have been shipped about the 15th of this month. With this in mind we expect to have crew on hand for the dismantling of Hawkes boiler and installation of extension within a short period of time. We would like to hear from you as to whether or not you will be in position to allow us to start

dismantling boilers on their arrival.
