# Introduction

Forestry educational and assistance programs are available to Idaho landowners from a variety of sources. Some of these sources are public and sponsored by government agencies. Some sources are private, provided by consulting foresters for a fee. Some are associations, made up of private forest landowners, Christmas tree growers, or citizens interested in participating in the conservation of specific habitats or wildlife species.

Whatever your situation, there is probably an organization or individual that can help you. Publications, educational programs, technical

advice, financial assistance, and private organizations are available to help you manage all the components of your forest land.

If, after reading this publication, you are still unsure where to obtain the assistance you need, your county Extension Office or one of the other public agencies listed will be able to refer you to the proper source. No endorsement is implied nor intended for any individual or group listing. This publication was developed for your information only.

# Consumer's Guide to Professional Forestry Assistance

Forest owners often search for help when they want to improve the health of their land or make some income from a timber sale. What criteria can you use to decide who will best serve you? There are many forms of forestry credentials to help you determine who is most qualified to help you. It is helpful to understand some of the terms...

*Forester* - A forester is someone who has earned a bachelors, or higher, degree from a college or university in a forestry program which has been accredited by the Society of American Foresters (SAF - see below).

*Forestry Technician* - Forestry technicians often have a two-year degree (commonly called an associate degree) in forestry or a related natural resource area. They can provide a number of basic applied forestry services such as tree planting, slash treatment, and thinning. They can be a member of the Society of American Foresters.

Society of American Foresters (SAF) - A national association of forestry professionals. Most members are foresters with four-year forestry degrees, but some are also forestry technicians or employed in fields closely allied with forestry. The SAF fosters professionalism among foresters and has a code of ethics SAF members must follow. To confirm if a forester is a current member of SAF, is a "certified forester" (see below), or whether a given college or university forestry program has been accredited by the SAF, contact the SAF at: 5400 Grosvenor Ln., Bethesda, MD 20814-2198. Phone: 301-897-3690. Certified Forester (C.F.) - A credential available to individuals who have a bachelors degree, or higher, in forestry or a related degree with forestry coursework; have five years of professional forestry experience; adhere to state and federal forestry laws and standards of professionalism; and complete 60 hours of forestry professional development every three years. The program is administered by the SAF.

Consulting Forester - Someone with a bachelors degree, or higher, in forestry who provides forest management recommendations and related services for a fee (e.g., percentage of a timber sale, per hour, per acre, etc.). A consulting forester represents the best interests of the landowner who employes them and helps that landowner achieve their goals. For more on consulting foresters see page 17.

*Licensing/Registration* - Some states require licensing for practicing foresters. Idaho currently has no laws requiring licensing or registration for foresters or forestry technicians.

Wildlife Biologists, Range Managers, Etc. - Foresters are trained to work with a variety of forest values, but are usually strongest when it comes to managing trees and other forest vegetation. If you have a strong interest in managing wildlife or similar specific resources, consider contacting a professional who has been trained in that natural resource discipline. Some consulting firms employ individuals with expertise in these areas. Regardless, check for related credentials as you would with foresters (e.g., The Wildlife Society instead of SAF).



# Public Agencies and Organizations

### University of Idaho Cooperative Extension System

The Cooperative Extension System is a three-way partnership of the University of Idaho, the U.S. Department of Agriculture, and county governments. Extension educators help forest owners learn and apply the latest research-based knowledge to their most critical issues and needs. They do this by translating research from the University of Idaho (UI) and other sources into practical, objective, educational programs and materials. Examples include:

Woodland NOTES, a bi-annual Extension Forestry newsletter, provides timely, research-based articles on forest management to over 10,000 Idaho forest owners and managers. If you would like to receive Woodland NOTES, free of charge, please call (208) 885-6356 to add your name to the mailing list. *Extension educational activities* are offered as short evening programs, multi-session programs, field days, and many other formats to accommodate peoples' varied learning styles and schedules. Many of these programs are announced in a calendar sent annually to everyone on the *Woodland Notes* mailing list.

*Extension publications* are available on virtually every topic of value to Idaho forest owners. They are developed at the University of Idaho or other land grant universities, such as Oregon State University or Washington State University.

# Idaho Department of Lands (IDL)

The Idaho Department of Lands (IDL) provides direct on-site assistance to forest landowners through various forestry programs, including the *Idaho Forest Stewardship Program*. IDL Private Forestry Specialists evaluate current forest conditions and suggest forest management practices to meet landowner objectives. Advice is available on: growing trees, harvesting timber, enhancing and protecting fish and wildlife habitat, forest improvement and protection, forest taxation, community forestry, and other topics of interest to landowners. IDL Private Forestry Specialists are often familiar with local consulting foresters and logging contractors that can help landowners successfully complete management objectives. IDL Private Forestry Specialists administer forestry cost-share programs and inspect logging operations for compliance with the Idaho Forest Practices Act.

#### Stewardship Incentive Program (SIP)

The Stewardship Incentive Program provides costsharing to landowners for tree planting, forest improvement, fish and wildlife habitat enhancement, riparian and wetland enhancement, soil and water protection, and other forest stewardship practices. To qualify, the landowner must have a written forest stewardship plan. For more information, contact the IDL forester nearest your property.

# Idaho Department of Fish and Game and the Habitat Improvement Program (HIP)

Habitat holds the key to the future of upland game and waterfowl in Idaho. The Idaho Department of Fish and Game protects and preserves Idaho's game and non-game resources and habitats.

### Habitat Improvement Program (HIP)

Creating and improving habitat is the goal of the Idaho Department of Fish and Game's Habitat Improvement Program (HIP). HIP applies to both public and private lands, recognizing the vital importance of private lands to Idaho's wildlife, especially to most upland game and many waterfowl populations. The program is designed primarily to help private landowners use their property to benefit game birds. Funds generated from upland game and waterfowl stamps, artwork, and product sales are used for cost-sharing on habitat projects by the Department in partnership with private landowners, non-profit organizations, and state and federal agencies. # U.S. Fish and Wildlife Service and the Partners for Wildlife Program

### Idaho Soil and Water Conservation Districts (SWCD), U.S.D.A. Natural Resources Conservation Service (NRCS), and Resource Conservation and Development (RC&D) Councils

Soil and Water Conservation Districts (SWCD's) are subdivisions of state government, much like school boards. Each district is governed by a board of five to seven volunteer supervisors, who are local landowners or farm operators elected by local citizens. Soil and Water Conservation Districts use assistance from various public and private agencies to develop and implement programs to protect and conserve water and other renewable resources on non-federal lands.

The Natural Resources Conservation Service (NRCS) provides technical assistance with soils, conservation practices, and resource management planning to landowners and others. Included in these plans are specific recommendations for achieving a landowner's short- and long-term objectives and goals, and proper use of the natural resources present on the property. The NRCS also administers funding for the Resource Conservation & Development (RC&D) areas. Resource Conservation & Development Councils (RC&D's) are locally organized, sponsored, and directed organizations of people that receive technical and financial help from the U.S.D.A. and other organizations to conserve and use natural resources.

#### Forestry Incentive Program (FIP)

The Forestry Incentive Program (FIP) was authorized by Congress in 1973 to share the cost of tree planting and timber stand improvement with private landowners. FIP is available in counties designated on the basis of a Forest Service survey of total eligible private timber acreage and acreage potentially suitable for the production of timber products. In the state of Idaho, counties eligible for FIP cost-sharing are: Adams, Benewah, Boise, Bonner, Boundary, Clearwater, Elmore, Idaho, Kootenai, Latah, Lewis, Nez Perce, Valley, and Washington.

# Idaho State Forest Tax Assistance

### County Tax Assessors Offices

County assessors record all property in Idaho by categories. Each category represents a different use. In Idaho, the 1982 Forestland Taxation Act created two forest tax options, placed in categories 6 and 7. These categories provide a partial tax liability exemption to forestland owners who manage their property for long-term timber production. Owners of more than 5 acres of forestland in Idaho are eligible to apply for special forestland taxation treatment if (1) their property is used primarily for the continuous purpose of growing and harvesting marketable tree species, and (2) they have designated their property as forestland by means of an application on file with the county assessor.

# Consulting Foresters

Consulting foresters offer a wide range of independent forest management services. A consultant is hired by a forest landowner on a fee basis and works directly for the individual landowner. Consultants can provide more in-depth and comprehensive services than foresters employed by public agencies.

Choosing a consulting forester is similar to choosing other professionals to work for you. Ask for references and talk to forest owners who have previously employed the consultant. Discuss the job and fee prior to making commitments. A consulting forester works for you and should be in business to do the best job possible for you.

### Industrial Forestry Programs

Some forest products companies offer landowners technical assistance in managing their forestlands. Each company program differs in the amount of assistance provided and the terms under which assistance is given. Companies that offer services usually do so at no direct cost. Other costs for preharvest or post-harvest activities may be deducted from the stumpage price. Companies that offer assistance programs often wish to purchase any forest products sold from the land. Others ask for a formal agreement, often called a "first right of refusal". #### American Tree Farm System

American Tree Farm is an honorary designation for privately owned land managed for the growth and harvest of repeated forest crops and adequately protected from fire, insects, disease, and destructive grazing. Tree Farms are often managed for wildlife and aesthetics, as well as timber production.

Prospective Tree Farms are certified by a forester after an inspection of the woodland acreage. Existing Tree Farms are re-inspected every 5 years. Unmanaged woodland is acceptable as a "Pioneer Tree Farm" if the owner has a written management plan prepared by a forester and states his/her intent to follow the plan. Participants in the American Tree Farm Program receive a sign, certificate, and initial subscription to the national *Tree Farmer* magazine. There is no cost to the landowner.


