Elk Conference

A large Idaho delegation attended the Western Elk Council in Bozeman, Montana March 2 - 4, 1965. Two days were spent on field trips and evenings plus one day were devoted to presentation of technical papers, reports, and discussions of management problems. Next year the conference will be held in Oregon. There was some discussion of converting the informal information exchange-research suggesting organization from an "elk" to a "big game" council with emphasis on elk every several years.

An Idea - That's All

A committee of four wildlife men was appointed to discuss a problem and bring a decision to a group of 30 for approval. The committee held two meetings, each two hours long $(2 + 2 \times 4 = 16 \text{ man hours})$. The committee reported to the group and the report was discussed for one-half hour $(1/2 \times 30 = 15 \text{ man hours})$. The report was modified from its intent to return to the pre-committee status quo. The total man hours involved (16 + 15 = 31) times \$2.50 per hour (minimum) produced a cost of \$152.50 for the decision. Was it worth it?
