This is a very important number. Our members in the Boise area should use this number on a regular basis. Other members are encouraged to use it on important issues. THE ISSUES - WHAT ACTION YOU CAN TAKE

There are several issues that we must become familiar with. In this and upcoming newsletters we will briefly update you on some of the issues, tell you where you can obtain additional information, and suggest ways you can be effective.

Birds of Prey Conservation Area MOTA MARIEMON ON RESIDENCE SERVICE SER

Update: In the closing months of the Carter administration Cecil Andrus, by executive order, declared 480,000 acres of BLM lands as the Birds of Prey Conservation Area. This area will be protected from further agricultural development only <u>until</u> Congress decides what action to take. The declaration in no way affects existing agricultural operations, livestock grazing, mineral and gas exploration, or National Guard exercises on the area.

The area supports the densest nesting population of raptors in North America and possibly the world. The expansion was necessary to protect the habitat of the Townsend ground squirrel and other rodents which constitute a large proportion of the raptors' prey base.

Action To Take: Now is the time to act on this issue. Write to our Washington congressional delegation and Morris Udall. Send a copy of the letter sent to Senator McClure to Secretary of Interior James Watt. It is important that he knows there are Idaho citizens that want this land preserved for future generations.

Sagebrush Rebellion

Update: The incoming Reagan administration with Secretary of Interior James Watt have put new wood into the fire of Sagebrush Rebellion proponents. We have to be vigilant in our efforts to weed out the lies and half-truths of their campaign and let our politicians and the public know the facts. The rally held in front of the Capitol on January 26 was the start of a statewide campaign to do just this.

If BLM and Forest Service lands are transferred from the federal government, 570 million acres in the U.S. would be lost. If only BLM land is transferred, 350 million acres would be gone. There is data to show that the loss of \$10 to \$14 million/year can be expected in Idaho if the 12 million acres under BLM management were transferred to the State (this includes \$3 million/year paid to Idaho counties to make up for property lost on the tax rolls). The state would have two courses of action open to it: 1) raise taxes to cover the loss or, 2) sell the land. Notice this sum doesn't even include the cost of land management or fire control. Sagebrush Rebellion proponents would opt for sale to private interests and the NO TRESPASSING signs would go up.

Action To Take: Write to your state and federal legislators. Let them know exactly how you feel about this blatant land grab scheme. It has nothing to do with state rights! Write to Secretary James Watt, too, he's one of the founding fathers of this rebellion.

We have included a petition to pass around for Idaho citizens to sign. To date approximately 8,000 signatures have been collected. These petitions are important as a show of strength. Please do your part.

Fish and Game Funding Package

Update: The Fish and Game funding package includes several key issues. The ones likely to be most controversial are the proposed increase in license fees, nongame funding, and the pheasant stamp. The proposed fee increases would go into effect in 1982 and are necessary to keep the Department of Fish and Game solvent and to maintain its current level of fish and wildlife management. A companion bill would tie future fee increases to the Gross National Product price index. This would allow the Fish and Game Commission to match changes in the rate of inflation. Nongame funding would be supported by an income tax checkoff system. Under the proposal, Idahoans could contribute a portion of their state income tax refund or they could donate a sum after paying their tax liability. A \$5 pheasant stamp will also be proposed. The funds would be used to pay the landowner for development and maintenance of pheasant habitat. The funds could be used on either public or private lands.

Action To Take: Write to the chairmen of the House Appropriations Committee and the Senate Finance Committee. You may also want to communicate with your local representatives. When the bill is about to be up in the Legislature we will see how our phone network performs. This would be a good issue to use the Legislative Information Center (334-2000).

We're <u>for</u> the birds.
