#### Certification

It is apparent that the appointment of Lew Nelson to the Certification Committee (Lew was the Chairman and sole Committee member) was a wise choice. Lew has given out over one hundred-fifty packets to prospective applicants. His screening of requests and follow-up to professionals in Idaho would indicate most of those who received packets will apply for certification.

I am hoping to see a strong showing from Idaho when the next roster of certified biologists is received.

#### Belt Buckles

Our enterprising Secretary-Treasurer, Jim Nee has been investigating methods in the development of new sources of revenue for the Wildlife Society. The popularity of the cast belt buckle led him to pursue the possibility of the Idaho Chapter sponsering a Wildlife Society Belt Buckle. This has been a well-accepted item with other professional organizations including the Society of American Foresters (SAF).

Jim has been in contact with the parent society, the NW Region and a belt buckle manufacturer in an effort to find out the pros and cons of such an undertaking.

### New Chapter Awards Program

The Idaho Chapter TWS is establishing an awards program that will recognize outstanding wildlife work performed in Idaho. An awards committee has been appointed to develop operational guidelines and get the program moving. The committee is presently reviewing the guidelines that our neighboring chapters are using in the operation of their awards programs. The recommended guidelines to be submitted to the chapter's executive committee will reflect these other procedures.

The awards committee and the executive committee feel it best to initially have only one chapter award. This award will be made to a professionally employed wildlife biologist and will be called the Professional Wildlifer Award. Nominee's need not reside in Idaho, but the work which qualifies the individual must have been performed in Idaho. Awards can be shared if the accomplishment is the work of more than one biologist. The awards committee will screen the nominations and recommend all highly deserving individuals to the executive committee. The executive committee, consisting of the chapter president, vice president, secretary/treasurer, and the awards committee chairman will make the selection. It will not be mandatory to select an individual every year. An appropriate award will be presented to the award recipient at the chapters annual meeting.

A nomination form has been attached to this newsletter. If you feel one of our professionally employed colleagues deserves recognition for outstanding wildlife work, please submit the form as soon as possible. Nominations received after December 17, 1979, will not be eligible for this year's award.

## President: Gary Will

Gary C. Will was born in eastern Colorado on a farm near La Juanta in 1941. He attended school in Rocky Ford and graduated from Rocky Ford High in 1959. Gary attended Otero Junior College at La Juanta for one year after high school then joined the U.S. Marine Corps. He served for three years with an amphibious assault group stationed at San Diego. After discharge, Gary returned to Otero Junior College for another year then transferred to Colorado State University. He obtained his Bachelor of Science Degree in wildlife management in 1966. For the next two and one half years Gary studied the productivity of Canada geese along the front range of the Rockies in Colorado and obtained his Master's Degree from C.S.U. in 1969. For the next three years, under the Idaho Cooperative Wildlife Research Unit, he researched the population dynamics of Northern Idaho white-tailed deer and obtained his PhD from the University of Idaho in 1972. He began his career with the Idaho Department of Fish and Game in 1972 as a Conservation Officer stationed at Arco. He served in that position for two years then accepted a promotion to Regional Wildlife Manager for Region 4, at Jerome. He has served in that capacity for the past five years. During the last 15 years, at one time or another, Gary has been an active member of the American Institute of Biological Sciences; The National Wildlife Federation; The Society of the Sigma Xi; Xi Sigma Pi; The Wilderness Society; The American Society of Mammologists: The Wildlife Society: The Wildlife Society Central Mountain Plains Section; The Wildlife Society Northwest Section; and the Wildlife Society Idaho Chapter.

Vice President: Lew Nelson

Lew received a B.S. degree in Wildlife Management from Colorado State University in 1966, an M.S. from Utah State University in Wildlife Biology in 1970 and his

Ph.D. in this field from Utah State University in 1973.


At the present time, Lew is an Associate Professor in the Department of Wildlife at the University of Idaho. His duties include teaching and continuing education; which involves establishing educational wildlife programs for professional and lay audiences. Before coming to Idaho in 1978, Lew worked for six years as a Wildlife Specialist for the University of California Cooperative Extension with state-wide responsibilities in Wildlife Management, Inland Fisheries, and Outdoor Recreation. He also worked with the Colorado Division of Wildlife for one year on deer and fisheries research projects.

Lew has been an active member and supporter of the Wildlife Society since 1965 when he was President of the Colorado State University Student Chapter of TWS and Chairman of the Western Students Wildlife Conclave. He also served as President of the Western Section of TWS and the Sacramento Chapter of TWS. In 1979 Lew acted as Chairman of the Certification Committee of the Idaho Chapter of TWS. On a national level, he has been a member of the Student Affairs Committee (1968 and 1971), Chairman of the Conservation Education Award Committee (1974), and Chairman of the Position Statements Committee (1978 and 1979).

Vice President - Phil Lee

Phil is a 1962 graduate of Colorado State University with a B.S. in Wildlife Management where he graduated with honors.

In 1962 he began work with the U.S. Forest Service in Oregon, subsequent assignments have been District Ranger, and Fish & Wildlife Staff Officer. He is currently Branch Chief - Fish-Wildlife, Range & Soil & Water at Targhee N.F. St Anthony. He has been a member of TWS since 1962 and is currently President of Lyman Richwine Chapter of Society for Range Management.
