#### Legislative Actions:

The newly formed ad hoc legislative action committee of the Idaho Chapter of TWS held its first meeting on 16 December, 1980. Important upcoming State and Federal legislative issues were discussed and a plan of action formulated. The major issues included the Fish and Game funding package, a State river preservation system, potential land transfers from INEL, the Sagebrush Rebellion, dredge mining, DO standards, and repeal on watering down of the statewide planning legislation. On the Federal level Senator McClure was the center of discussion, especially his actions concerning the Birds of Prey National Conservation Area and transfer of Animal Damage Control to the U.S.D.A.

It was agreed that the Chapter and its individual members should become more involved in informing legislators and the public on issues directly affecting the biological resources of Idaho. Chuck Blair will head up this drive to increase TWS input on legislative issues. We hope to convince TWS members to contact their legislators, both before and during the upcoming session concerning their stands, as professional wildlife biologists, on the above issues. Often, as few as 5 letters on an issue can change a critical vote. A statewide TWS member telephone network will be established to dispense information on upcoming legislative issues requiring our input. Chuck is looking for people around the State to be regional coordinators, spreading information to other members in those areas. If you can help please contact him as 345-5310 (office) or 336-9345 (home). If everyone lends a hand we can influence these important decisions a no one person will have to carry the load alone. United we stand, divided we fail, and deservedly so.

A very important current issue needing immediate letters of support is the proposed Snake Rivel Birds of Prey National Conservation Area. Senator McClure has already tried to scuttle protection of this multiple-use wildlife habitat. Send letters to all members of the Idaho Congressional delegation and Interior Department Secretary nominee James Watt, if you care at all. Wildlife Conservation could be in for a rough time with the new administration, and this is a chance for us to get our inputs in early. First impressions really do count, so <a href="Let's get after it">Let's get after it</a>. Now::

Membership and Dues (Oh no, is it that time already!??)



In December, 1980, The Wildlife Society had its own belt buckle available for purchase by members. The Western Heritage Company casts and markets them for \$12.50 (bronze) and \$13.50 (polished pewter), plus \$1.00 for postage and handling. The buckle's front design is shown above. The back of the buckle includes a plaque displaying the Society objectives. Buckle backs are serially numbered as they are purchased.

The Idaho Chapter nurtured the buckle from conception to birth. Therefore, The Chapter will receive a 15% royalty from each sale. The Chapter will use the royalty for numerous activities e.g. to help the TWS Building Fund, to print papers presented at our annual meetings, to sponsor high school youngsters at environmental workshops, and more.

The buckle has been approved by the TWS executive council. It is only available from Western Heritage Company and the company guarantees that you'll be satisfied with it. ## WILDLIFE-LIVESTOCK RELATIONSHIPS SYMPOSIUM NEW DATES - APRIL 20-22, 1981

The Wildlife-Livestock Relationships Symposium will be held immediately prior to the Northwest Section of The Wildlife Society annual meeting April 23+24. This is an excellent idea so the Symposium is rescheduled for April 20-22, 1981 in Coeur d'Alene, Idaho.

Sponsored by the University of Idaho, the objectives of the Symposium are to document and discuss aspects of wildlife-livestock interaction on forest and rangelands in the western United States. Specific sessions will include (1) impacts of special grazing systems on wildlife and wildlife habitat; (2) effects of grazing riparian zones on wildlife and habitat; (3) wildlife-livestock competition for forage and space; (4) wildlife-livestock behavioral interactions; and (5) predator-livestock relationships.

Tentatively, 43 applications for papers were received. If you are interested in attending, please notify Dr. Jim Peek, Department of Wildlife, University of Idaho, Moscow, Idaho, 83843 or call at (208) 885-6434. This will help in making arrangements for meeting rooms, lodging, etc. You will also be put on a mailing list for further details about the Symposium and Chapter/Section Meeting.

#### EINARSEN AWARD

In 1966 the Northwest Section of The Wildlife Society established the Einarsen Award in honor of Arthur L. Einarsen. This award is presented annually to an individual in recognition and

commendation of his/her contribution to the wildlife profession. The actual presentation will be made at the Northwest Section meeting in April, 1981.

Nominations are now open for the Einarsen Award according to the following guidelines:

- 1) Nominations must be accompanied by a justification brief and a resume of the qualifications of the nominee.
- 2) Nominations must be postmarked no later than December 30, 1980.
- 3) Nominees must have contributed to wildlife conservation within the geographic area covered by the Northwest Section.

#### 1981 Professional Wildlifer Award

Nominations are being sought for the Professional Wildlifer Award, which is to be presented at the Annual meeting in April. As most of you will remember, this exclusive Idaho Chapter Award was established last year to give recognition for outstanding contribution and achievment within the wildlife profession. Sam McNeill was the first recipient of this award.

As a reminder, the following guidelines should be followed in selecting nominees:

Recipient of the award must be a professionaly employed wildlife biologist who has made an outstanding contribution to wildlife resources in the State of Idaho.

Awards may be shared if the accomplishment is the work of more than one biologist.

The work which qualifies an individual for the award must have been performed in Idaho. However, the recipient need not reside in Idaho.

Recipients are not required to be Wildlife Society members, either State or National.
