



JACK CONNELLY - Secretary

Education: B.S. - Wildlife and Fish Resources, University of Idaho/1974

Work History: After graduating from Washington State University, JACK was employed by INEL-EG&G Idaho as a Wildlife Biologist. In 1984 he changed jobs and started to work for the Idaho Department of Fish and Game (IDFG). In his tenure with IDFG he has worked with numerous sage grouse projects, three mule deer studies, an elk study, and is presently starting to develop a sharp-tailed grouse study.

Thoughts on the Idaho Chapter: As an officer, JACK would like to see a program established to encourage more involvement of the wildlife professionals in TWS (Idaho Chapter). He would aggressively work on the development of a program that would help to improve this situation.

SIGNE SATHER-BLAIR - Secretary W MINISTER OF PRINCE

Education: B.S. - University of Nebraska, 1975;
M.S. - South Dakota State University, 1979

Work History: I am currently a wildlife biologist with the U.S. Fish and Wildlife Service in the Ecological Services Office. I primarily work with the Corps of Engineers and Bureau of Reclamation on existing and planned major federal water projects. I have been active in the Chapter since moving to Boise in 1980. I have been Chairman of the Conservation Affairs Committee and have organized the fund-raising auction each of the last 3 years. Running for elected office is the next logical step in my involvement in the Idaho Chapter.

Thoughts on the Idaho Chapter: I think it is the Chapter's responsibility to support and promote education at all levels in the fields of ecology and natural resource management. I also believe the Chapter has a responsibility to comment on and become involved in land management issues that may effect wildlife resources. If elected Secretary, I plan to do all I can to make the Chapter even more effective in these areas.

H. JEROME HANSEN - Secretary

Education: B.S. - Environmental Biology - Emporia State University, Kansas, 1979

M.S. - Wildlife Management - West Virginia and a standyldman University, 1982 and you be about a description

Work Experience: I have worked as a Biological Technician with the U.S. Fish and Wildlife Service in Boise, as a District Biologist with the Kansas Fish and Game Commission, and currently as a Wildlife Research Biologist with the Idaho Department of Fish and Game, involved with wildlife mitigation planning for hydroelectric project impacts. Over the last 3-1/2-years, I have had the pleasure of experiencing many of Idaho's backcountry treasures and plan to always do what I can to make sure they remain.

Thoughts on Idaho Chapter: I have accepted the nomination as Secretary for the Idaho Chapter of the Wildlife Society because of a belief that we should all get involved when offered the chance to help the Idaho Chapter and ultimately the Idaho resource. My past experience with the Idaho Chapter includes 7 months as the Conservation Affairs Committee Chairperson.

Work History: SAM started work with BLM in 1978 as the Jarbidge Resource Area Biologist. He worked with IDFG in the development and management with the Isolated Tracts program south of Boise. In 1982 he moved into the Cascade R.A. of the Boise District and began working with Columbian sharp-tailed grouse, big game winter range management and the management of the Black Canyon long-billed curlew area. Sam has been active in committee work for both the National and Chapter level TWS.

Thoughts on the Chapter: SAM would like to see a more aggressive membership drive that would encourage more professionals to join the Chapter. He would also like to see the annual meeting moved around the state between Moscow, Pocatello, and Boise.

PAUL MOROZ - Treasurer

Education: B.S. - Wildlife and Fish Resources, University of Idaho

Work History: PAUL started with the USFS in north Idaho as a seasonal employee in 1974. He has served as a District or Zone Wildlife Biologist for the USFS in north Idaho, western Washington, western Oregon, and southcentral Idaho. Presently he is a Zone Biologist for the Emmett and Lowman Ranger Districts.

Thoughts on the Idaho Chapter: PAUL would like to see more involvement of the professional wildlife biologist in the Idaho Chapter of the Wildlife Society. He also would like to encourage a stronger communications network between the private, State, and Federal employees that are involved with wildlife management. PAUL would work to improve these two items if he were elected.

Work Experience: For the last 3 years, I have lived in Boise while working for the Idaho Fish and Game as a wildlife research biologist on a state-wide hydropower mitigation program.

Thoughts on the Idaho Chapter: I believe involvement in Idaho's wildlife and environmental issues is very important. If elected to the office of Treasurer, I will serve the Chapter and the wildlife resources of Idaho to the fullest extent of my energy and abilities. I have gained a knowledge of Idaho through 10 years of wildlife work, during which I have lived in Pocatello, Soda Springs, Palisades, Moscow, and Boise.


RIDE BOARD

WESTERN RAPTOR MANAGEMENT SYMPOSIUM AND WORKSHOP

As mentioned in the last newsletter, the Idaho Chapter and the National Wildlife Federation are coorganizing the Western Raptor Management Symposium and Workshop which will be held in Boise from 26 to 28 October, 1987. Participating states are Alaska, California, Colorado, Hawaii, Idaho, Montana, Nevada, Oregon, Utah, Washington, and Wyoming. The meeting is the second in a series of five regional symposia and workshops coorganized by the National Wildlife Federation to assimilate technical information on the status and management of raptor populations. The symposium, which immediately procedes the Raptor Research Foundation's national meeting, will feature sessions on the status of western raptors, status of raptor habitats, impacts and mitigation, as well as workshops and poster presentations. Proceedings of the symposium and workshop will be published as part of the National Wildlife Federation's Scientific and Technical Series.

This is a great opportunity for the Chapter to become active in Wildlife Conservation. The Chapter will be responsible for logistics for the symposium and workshop, including arrangements, facilities, registration, and social functions. Many Chapter members are presently involved. MIKE KOCHERT is the local coordinator of the symposium and workshop; KAREN STEENHOF and MIKE SCOTT are members of the Coordination (Program) Committee; JAY GORE is in charge of the arrangements; and CRAIG GROVES and DAN HERRIG are handling registrations. The National Wildlife Federation will split any residual funds with the Chapter. The success of the symposium and workshop depends to a large extent on the contributions of Chapter members.
