### Nominations for TWS Awards

The Wildlife Society is seeking nominations for two prestigious awards to be presented in 1989. These are the Honorary Membership Award and the Special Recognition Service Award.

The SPECIAL RECOGNITION SERVICE AWARD is intended to honor any person or group who has made an outstanding contribution to: the wildlife profession, wildlife conservation, management, science, or knowledge. The HONORARY MEMBERSHIP AWARD is intended to recognize continuous long term outstanding service in any area of concern to The Wildlife Society. Any practicing or retired wildlife

professional who is a member of The Wildlife Society is eligible for nomination.

Each nomination should include:

1. Nominee's full name, present position, address and phone number.
2. Nominator's and endorsers' names, addresses and phone numbers.
3. A concise statement justifying the nomination, including the specific nature, time and place of the nominee's outstanding service and accomplishments. Try to address such criteria as difficulty, insight, scope, importance, acceptance, application, value, impact, and the geographic scope of contribution.
4. At least three signed statements of endorsement.

Nominees will be competing nationally for the awards, so it is important that the material supporting the nomination is concise and specific. To expedite evaluation by the Awards Committee, please send nominations by August 30, 1988, directly to the Committee Chairman:

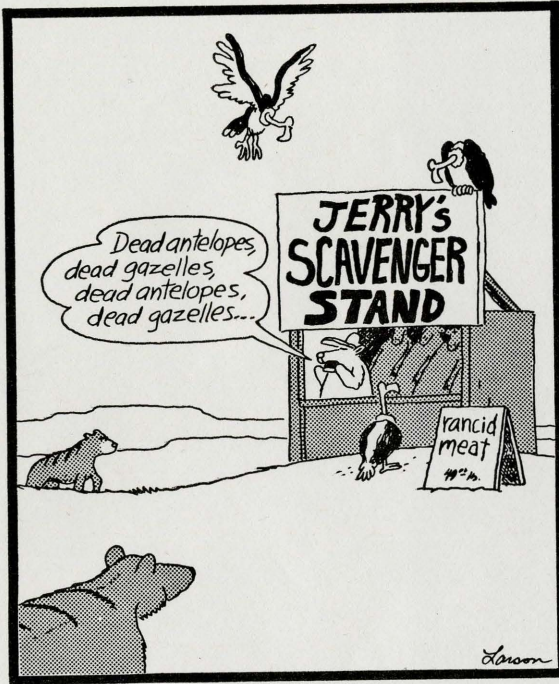
### Executive Board Meeting, Northwest Section TWS

#### IDAHO CHAPTER - TWS FIELD TRIP AUGUST 5-7, 1988, IN BEAR VALLEY

You are cordially invited to attend this summer's field trip to one of Idaho's great summer wildlife havens located in Bear Valley at the headwaters of the Middle Fork of the Salmon River.

Bear Valley Creek holds one of the last truly wild populations of chinook salmon in the state of Idaho. Bear Valley and vicinity holds high promise for recovery of the gray wolf in Idaho. A mosaic of mountain meadows interspersed with lodgepole timber helps create ideal summer range habitat for elk. Nearby, Deadwood Reservoir supports a healthy population of landlocked sockeye salmon. Over 50,000 acres burned under wildfire conditions between August and October of last year, involving forest and meadow. There's much to see. Come to relax, examine some ideal fish and wildlife habitats, enjoy good conversation and become familiar with another part of scenic Idaho.

An agenda and map are included in this newsletter. The schedule will accommodate those who arrive Friday evening and those who want to joint us on Saturday morning. Bring your own camping gear and food. A barbeque grill will be provided. Some liquid refreshments will be provided by the Chapter, but you may wish to supplement that with your own. #### FISCAL REPORT

The Idaho Chapter's funds are held in a premium checking account at the First Interstate Bank in Boise. This account totaled \$5,787.61 as of 5/31/88. The current interest rate earned is 4.3%, which adds about \$20-\$25 to the account each month.

The largest single expenditure made by the Chapter in 1988 was paid to the Red Lion for our annual meeting arrangements in the amount of \$1,456.02. Payments have also been made recently to Q's Trophy for \$37.05 and for mailing expenses.

The primary expenses we face this summer include costs associated with getting the summer newsletter out. While CH2M Hill has paid most of the newsletter costs in recent years, we must now get the job done at a printing shop. The Chapter will also cover some costs for refreshments associated with the summer field trip in Bear Valley.
