IDAHO TWS SUPPORTS WOLF PUBLICATION

RESEARCH NOTES FROM IDFG

FISHER STUDY

Jeff Jones of the Forest Service has agreed to take over the fisher study on the Nez Perce Forest and use the data for a masters degree while still employed by the Forest Service. Actual field studies will commence July 1, with Jeff's wife Deb working for the Department as a biological aid to assist in data collection for the project, she will radio track and conduct required habitat analysis on a full-time basis. For this study, the original objectives have been narrowed to document fisher habitat use with an emphasis on the importance of old growth. Prior to actual field activities, two aerial tracking flights were completed to determine the status of the nine fisher trapped and instrumented with radio last winter. A total of eight fishers were located with six remaining within the Newsome Creek drainage where most of the intensive field activities will occur.

GRIZZLY BEAR STUDY

The grizzly bear study was in full swing this month. The trapping crew of Don Young and Kyran Kunkel successfully trapped and instrumented five bears. Currently we have six bears with functioning radios. Four of the five bears trapped were retraps and the fifth was a yearling of the sow originally trapped in the Selkirks. The high percentage of retraps may suggest that the Selkirk grizzly bear population is not as "robust" nor numerous as our first year's trapping operations suggested. More trapping effort will be directed into previously untrapped areas to better understand or estimate the true bear population size for the Selkirks. The weather has allowed Steve Knick to maintain a flying schedule of three flights per week to monitor movements and document habitat use by these marked bears. Dave Volson, a University of Idaho graduate student, is conducting intensive analysis of aerial relocations on the ground to generate a detailed description of grizzly bear habitat.

CARIBOU STUDY

A caribou technical committee meeting was held to plan and discuss the upcoming transplant program. It was decided at this meeting to seek caribou from two sources in British Columbia, the Revelstoke herd that was originally targeted by the Caribou Augmentation Plan and the Itchas and Ilgachas mountain herd near Williams Lake. The Williams Lake situation comes as close to being a sure thing as there is, which substantially increases the potential for successfully moving It was agreed to set an objective to caribou this winter. move 12 animals from each area. By using this strategy there will be some assurance that animals will be transplanted in the preferred early winter time period, there will be a better mixture of animals for genetic and behavioral consideration, and the chances of obtaining an adequate number of animals will be enhanced. By shifting the transplant strategy to two sources the chances of successfully moving caribou this year is substantially enhanced.

Representatives from the IDF&G, USFS, USFWS, WDG, B.C. Fish and Wildlife, and University of Idaho met in Canada on June 4, to review plans for moving caribou from B.C. into the Selkirk Mountains later this fall. Agreement was reached to attempt to capture 10 to 12 animals from both the Revelstoke and Williams Lake areas for the transplant. The group believes this strategy presents the best chance to insure that some caribou will be moved into the Selkirks this year, considering that they may have difficulty capturing animals at Revelstoke. Gregg Servheen, project leader for IDF&G, is responsible for coordinating the capture program and monitoring the success of the transplant.

Why would the Idaho Chapter of the Wildlife Society like to have you in our membership?

The Wildlife Society is the professional society for you, the wildlife biologist. Our Society, indeed any professional society, is only as strong and effective as its membership.

The Idaho Chapter of the Wildlife Society is seeking information from non-members in an effort to (1) learn why working wildlife biologists and those working in closely related fields are not chapter members, and (2) learn how to make the Idaho Chapter more responsive to the needs of members, both present and potential.

Idaho is a large state with great ecological diversity. Biologists working for a variety of agencies, educational institutions, and private companies represent a vast wealth and diversity of knowledge and experience. The Idaho Chapter can serve as an excellent forum to share this knowledge with others, to learn from others what is going on in this diverse state, and provide a united front in solving wildlife related problems. The greater our active membership, the stronger and more effective our voice.

Why is this an important time to become a member of the Idaho Chapter?

This is an important time to establish your new membership with the Idaho Chapter of the Wildlife Society or revitalize an old membership because Idaho is changing in many ways. These changes are bound to affect our natural resources, including wildlife.

For example, every national forest in Idaho is preparing a forest plan that will determine how that forest will be managed over the next decade or two. This process involves resource allocations and management trade-offs. Once these plans are drafted and sent out for public review, a lot of misinformation is bound to be generated by special interests seeking to sway public opinion. Since wildlife is a key resource to many Idahoans, wildlife is likely to be wedged in the middle of any confrontation. The Idaho Chapter can serve as an accurate source of information from Idahoans seeking the "straight story" regarding wildlife resources on public lands. Your membership and participation can add to our source of credible information.

Another change involves our economic base. For much of Idaho's history, farming, logging, and mining have been the staples of our economy. Projections indicate that these industries will continue to be important in Idaho, but not to the same degree that they have been in the past. Tourism is expected to rise along many fronts, including hunting and fishing. Future impacts to wildlife from economic changes in Idaho may be much different than we are used to. The human presence may become a greater effect in coming years, possibly greater than habitat alteration. The Wildlife Society can help make such transitions more acceptable for wildlife, and your active membership can be important in that process.

MEMBERSHIP

Dan Herrig has compiled some interesting statistics about the Idaho Chapter membership that you might find interesting. We had 191 paid members in 1985 and 175 in 1986. We had 37 new members in 1986 meaning that 53 of our 1985 members did not renew their membership. There are also many working "professionals" who were not members in either 1985 or 1986.

We now have 359 past and present members on our database. We will be updating and asking for some new information when you pay your 1987 dues--namely, your work phone number, your employer, and your certification status. Please let us know if our mailing label for you is incorrect.

I hope your will help us reach out to those people who have chosen not to join the chapter, and we all know some, by giving them the questionnaire Paul and Bill have put together. If you don't do it, who will?

While we are on the topic of membership I would like to clear up an apparent misconception. A long standing member who had not paid his 1986 dues recently told me that he didn't belong to the national TWS and therefore could not belong to the Idaho Chapter. That is false. While membership in the

parent society is advantageous, it is not essential for membership in the Idaho Chapter. The resolution that would have required national TWS membership for State Chapter members was defeated. No one can use that excuse anymore.

EGIN-HAMER ROAD PROPOSAL

As many of you are aware, Freemont and Jefferson Counties are proposing to build a road across the Ninemile Knoll Area of Critical Environmental Concern. The area is so designated because of the large elk herd that winters in the area and other wildlife and botanical resource values. The BLM prepared an EIS on the project and rightfully concluded that construction of the road would have a devastating affect on the elk herd, significantly reduce hunter days in eastern Idaho, and result in a substantial monetary loss to the local economy. In the face of political pressure the BLM then ignored the facts and recommended that the road be built and closed in the winter.

The Idaho Chapter along with numerous other organizations responded to this fiasco at the public hearings and in writing. Mike Anderson presented testimony prepared by Jerome Hanson and other Chapter members. Our conclusion was that the road should not be constructed and that the Ninemile Knoll ACEC should be enlarged to include the remainder of the winter range not already included in the ACEC, an alternative not considered in the DEIS. Barring adoption of this scenario we recommended adoption of the No Action alternative.

RAPTOR SYMPOSIUM AND WORKSHOP

The Idaho Chapter, TWS, has agreed to serve as a co-organizer, along with the National Wildlife Federation, of the Northwest Raptor Management Symposium and Workshop. This meeting will be held in Boise during the fall of 1987 following the national meeting of the Raptor Research Foundation. Mike Kochert, is spearheading this effort. Mike, you will remember, was the unsuccessful Vice Presidential candidate in the last Chapter election. Mike has assured me he is not beginning his campaign for the 1987 election, but I'm not so sure.

BYLAWS CHANGES

The Bylaws changes I outlined at the Annual Meeting and described in the last newsletter must now be put to a vote.

The process of changing the Bylaws is described in Article X. Amendment to Bylaws.

ARTICLE X. AMENDMENT TO BYLAWS

- Section 1. PROCEDURE These Bylaws may be altered or amended by a majority of the Chapter members voting at any annual or special meeting if due notice of the proposed changes (Article VI, Section 1B) is followed. A member who will be absent from the meeting may file an absentee ballot (Article V, Section 2B).
- Section 2. CONFORMANCE No amendment to these Bylaws shall be enacted that results in a conflict with The Wildlife Society Bylaws. If these Bylaws are revised, the new revision must be approved by The Society before becoming effective.

Article VI, Section 1B - MEETING NOTICE - requires that members must be notified at least 1 month prior to annual and regular meetings and at least 10 days prior to special meetings.

In accordance with the Idaho Chapter Bylaws, I, as president of the Chapter, am calling a special meeting for the purpose of voting on the proposed Bylaws changes described below. The special meeting shall be convened at 5:30 p.m. on Thursday, October 23, 1986. The meeting will be held at Louie's Restaurant, 601 Main, Boise. Members who are unable to attend the special meeting may cast a vote on the proposed Bylaws changes by returning the absentee ballot provided below. Absentee ballots must be signed by the voting members and received by the Secretary no later than November 15, 1986.

The proposed changes are described briefly below. A more detailed description appeared in the April newsletter.

- Item 1 Split the office of Secretary/Treasurer into two
 positions, both to be elected by the Chapter membership.
- Item 2 Require that the Executive Board hold at least two
 meetings each year, including one at the annual general
 membership meeting.
- Item 3 Increase the Idaho Chapter dues from \$3.00 to \$5.00.


