NEWS FROM AROUND THE STATE

CRUCIAL MULE DEER WINTER RANGE DESTROYED

In a 10-day period in August, 1,700 lightning strikes occurred North of Emmett, Idaho. Thirty wildfires burned approximately 218,000 acres, most of which was considered crucial mule deer winter range. The area supported a wintering population of 4,000-6,000 deer, a variety of non-game species, and at least six species of upland game birds.

Fires burned hot and fast with daytime temperatures over 100°F and winds of 10-15 mph. The shrub components primarily sagebrush and bitterbrush, was completely destroyed in most burned areas. Riparian zones suffered various degrees of damage, from light to very severe.

An Emergency Fire Rehabilitation Plan was written to conduct and support the restoration efforts. The primary objective was to stop erosion and restore the wastershed in the burned area. The secondary objective was to restore the vegetative composition to preburn conditions.

The plan includes fall and spring aerial seedings of a grass/ shrub mix, aerial seedings of shrubs only, hand plantings of bitterbrush seeds and seedlings, and mechanical seedings of bitterbrush. Initially, 200 miles of fire-lines were aerial seeded and harrowed to reduce erosion. A 200-acre grass/ shrub seeding was completed this fall. Additional seedings are planned for early spring.

In October, the Idaho Department of Fish and Game conducted an either-sex deer hunt in Management Unit 32. Since about 80 percent of their winter range was destroyed approximately 3,000 animals were harvested. Haystacks have been paneled and orchard owners were contacted to try to minimize problems.

The Friends of Squaw Butte is a volunteer group organized to assist the BLM in rehabilitating the winter range. Working under the technical direction of BLM biologists, the group has been collecting and transplanting native plant seeds and seedlings. The members have worked diligently this fall and will renew their efforts next spring. Their goal is to plant each weekend from March through mid-May. Public interest is high and many sportsmen as well as conservation, professional, and school groups have volunteered to help in this effort.
