The belt buckle is very handsomely done, and I especially appreciate knowing that the first of this series of buckles, #1, was selected for me. I hope you will express my deep appreciation to other members of the Idaho Chapter.

The remarks for the occasion, which had been prepared for delivery by Daniel Stiles, President of the National Capital Chapter, were a fine summation of my principal work in the field of conservation and wildlife preservation. I'm grateful to you for the care with which they were prepared, and for their content.

As I look back over my 24 years in the Senate, I believe that my lasting legacy to Idaho may well be the beautiful and remote open spaces which will be saved by virtue of the special laws I sponsored: The Wilderness Act, The Land and Conservation Fund, The Wild and Scenic Rivers Act, and the legislation which created Idaho's Sawtooth National Recreation Area, Hells Canyon National Recreation Area, the Gospel Hump Wilderness, and the great River of No Return Wilderness, the largest in the lower 48 states of the Union.
