Minutes of the First Meeting Idaho Chapter of the Wildlife Society April 4, 1964

The organizational meeting of the Idaho Chapter was held in the Hotel Moscow, Moscow, Idaho at 7:00 A.M., April 4, 1964.

Kenneth E. Hungerford presided after the breakfast which was attended by 27 men.

Robert H. Giles, Jr. discussed the by laws with the group and amended them to their attached form. Discussion centered around membership and the need for associate members, and the mechanism for adoption and release of resolutions or statements by the Chapter.

A nominating committee chaired by Elmer V. Norberg presented two names of each of the three officer positions. Elected by secret ballot were: President, K. E. Hungerford, University of Idaho; Vice President, Hugh Harper, Bureau of Land Management; and Secretary-Treasurer, R. H. Giles, University of Idaho.

A motion was carried that the deadline for charter membership would be June 1, 1964.

David Neider, Program Committee chairman, discussed the report of the Committee previously sent to members. The need for local or area meetings was discussed and general agreement reached that such meetings or programs of the Chapter would be desirable. The by laws were amended to provide for small meetings having executive board approval.

The desirability of a summer program meeting, probably near McCall, was discussed. Such a program is to be planned.


Dr. Hungerford expressed the thanks of the new officers for the work done by the organizational committees.

Meeting was called to order at 10:20 A.M. by President Hungerford.

Sylvester suggested meeting at Moscow to discuss computer and radio isotope techniques.

Bizeau suggested a meeting at Coeur d'Alene prior to the Northwestern Section of the Wildlife Society to be held in Missoula, Montana in April.

Ideas were requested and the membership will be polled for a vote on the next meeting.

Hungerford raised the program committee's suggestion of chapter support of the two Idaho Youth Conservation Camps. The group seemed to favor support in some form of the northern camp. The southern camp is adequately instructed by the Department of Fish and Game.

The Chapter favors acquiring Nagel's <u>Techniques</u> of <u>Technical</u> <u>Writing</u> at a cost of \$.75 each for sale to its members at a profit over mailing costs.

Giles showed a conibear trap and a Virginia Commission of Game and Inland Fisheries field autopsy forms and collection equipment.

Hungerford discussed and demonstrated tranquilizer gun, archery, and anaesthesia techniques.

John Ormiston discussed the use of Tranamol anaesthesia on Cotourmix quail in their water supply. The advantages and disadvantages for field use and capture of birds was discussed. Various experiences of other participants were shared.
