

MINUTES, ANNUAL BUSINESS MEETING
IDAHO CHAPTER WILDLIFE SOCIETY
April 7, 1967

The Annual Business Meeting of the Idaho Chapter of the Wildlife Society was held at Moscow, Idaho, April 7, 1967, in conjunction with the Northwest Section Meeting. President Dalke opened the Meeting during the noon luncheon, following which Dr. Kenneth Hungerford made a few and general remarks.

Following the opening statements Mr. Fred Evenden, Executive Secretary of the National Wildlife Society spoke to the group. He stated that the National Association has been criticized as being too general. He also stated that the national group will be looking at the overall meeting system. He also stated that he felt that the local groups were better adapted at reaching members than the national group. He also stated that the work load at his office was rather overwhelming at times, but that he now has a secretary. He also stated that committee duties will be sent out in the near future. Mr. Evenden also drew attention to the Boy Scout Merit Badge series, which includes the many aspects of conservation and stated that it was an excellent series.

Following Mr. Evenden's talk the meeting was opened to questions. Mr. Bizeau stated that the Society pin was ^{clearly broken} too small. A general discussion followed, with the members present having varying views.

Dr. Dalke then asked the group what type of summer meeting they would like. It was generally agreed that the summer meeting should be held in southeastern Idaho this year.

Dear Dr. Dalke:
