These long term scenic and nature values will remain if present management is continued. We believe mining the area would be an example of a short term action that would benefit only a few and would significantly degrade the value of the area in the long term. Issuing a lease to allow mining in this area would be using very poor judgement. Consequently, the Idaho Chapter of The Wildlife Society strongly urges the Land Board to reject this lease application and not issue the lease. Thank you for consideration of these views.
