Dear President Hartung:


I am advised of the proposed program of the University of Idaho to complete the construction and development of the roof and end-wall structures of the Stadium facility on the Moscow Campus. The multi-purpose concept of the Stadium complex for inter-collegiate sports as well as intramural and internal University activities is creative and warrants support.

Since I attended the University in 1936, the School has remained a special place to me. It is a university in the classic and real sense of the word with its various colleges of undergraduate and graduate studies, and it has maintained its position throughout the years as a leading institution of higher education. The University enjoys the additional advantage of having its situs in a smaller community in which the academic and campus life is the predominating theme. The enclosed Stadium complex should serve to support and further the progress of the University in all of its aspects.

Bearing all these factors in mind and in recognition of your leadership, I desire to and do herewith pledge to the University of Idaho the sum of \$300,000.00 in cash to be utilized specifically for the construction and completion of the roof and end-walls of the multi-purpose Stadium complex. I am informed by my legal counsel, Mr. Campbell, that the gift should be made to the University of Idaho Foundation, Inc. It will be so done in periodic or in whole payment on or before March 1, 1976, dependent upon personal circumstances.
