Dear Friend of the McClure Center,



When asked why he put his hat in the ring for the 1966 U.S. House of Representatives election, Senator Jim McClure said: "There is an opportunity here this time...Will I sometime later in life look back and say, 'gee, I wish I would have done that?' So, I decided to try. There was an opening; an opportunity."

Jim and Louise packed the family in the 1965 Chrysler New Yorker station wagon and moved to Washington, D.C. **The new**Congressman also brought his Idaho-grown principles to Capitol Hill:

- Attention to detail and tireless exploration of public policy implications.
- Thoughtful pursuit and promotion of bipartisan collaboration for enactment and execution of sound public policy.
- Evidence and research as the basis to inform public policy decisions.

In 1991, after three terms as U.S. Representative and three terms as U.S. Senator and committee chair, Senator McClure brought these principles back to Idaho and trusted the University of Idaho to espouse these values in perpetuity. These core tenets form the foundation for the James A. and Louise McClure Center for Public Policy Research. For ten years, the McClure Center has conducted nonpartisan research, informed public dialogue and policy and engaged students in learning about public policy making with a focus on critical issues facing the state, region, nation and world — with impressive results and impact.

Jim McClure recognized a rare opportunity. So too has the McClure Center. The McClure Center is built on an exceptional foundation, and its unique and deliberate strategy included thought leadership from university presidents, former Congressmen and business leaders. In order to fully realize our true potential, **the McClure Center is launching an ambitious \$3 million capital campaign.** We are on the move and ask for your support.
