Last ~~May~~, as you know, Federal Criminal Indictments were returned against me at Boise Idaho. Four counts were involved. Last May, here in Moscow, I stood trial, and at that trial three of the counts were ordered thrown out. The remaining ~~trial~~ charged that I had made false statements in a Passport application in that I had falsely claimed American citizenship by falsely stating that I was born in New York City, when as a matter of fact I was born in England. After a protracted trial, which by the way entailed lots of misery to myself, wife and family, a Federal District Jury unanimously found me "NOT GUILTY". Twelve men, who heard the evidence, brought in that verdict. In spite of that verdict however, shortly after the trial, a Deportation warrant was issued and charges were laid that I am in this country in violation of the Immigration Act of 1924. They claim also that in 1935, when I made a short visit of one day to Toronto, I entered the United States without a visa etc. A hearing was held in Spokane Wash. in September last, and the examining Inspector, who ~~was~~ vicious throughout the entire hearing, recommended that I be deported.

To bring a deportation charge on a matter of citizenship after a Federal Jury have once brought in a "NOT GUILTY" verdict on practically the same charge, is, in my opinion vicious persecution and not legitimate prosecution. I BELIEVE THAT THAT VERDICT OF THAT JURY SHOULD HAVE FOREVER SET AT REST THE QUESTION OF MY RIGHT TO LIVE WITH AND PROVIDE FOR MY FAMILY AND MYSELF IN THE LAND OF THEIR BIRTH. I BELIEVE FURTHER THAT TO UPSET THE VERDICT OF A JURY IN AN EXECUTIVE PROCEEDING, AFTER A FULL AND FAIR TRIAL BEFORE COURT AND JURY, IS TO, IN EFFECT, DEPRIVE ME OF ~~MY~~ THE CONSTITUTIONAL RIGHTS AND SAFEGUARDS WHICH HAVE BEEN THROWN ROUND THE LIFE, PROPERTY, AND LIBERTY OF ALL WHO CALL AMERICA ~~THEIR~~ HOME.

I ~~don't~~ not think in ordinary cases this deportation warrant would have been asked for after a Federal Jury had once acquitted an accused man, as I was acquitted. I know a great deal however about who and what is behind these proceedings. Some day I'll tell you all about. The fact of the matter is that no stone will be left unturned in an effort to stop "PSYCHIANA" and to get me out of the way. This is not because my Teaching is false, BUT BECAUSE ITS TRUE AND THEY ARE AFRAID OF WHERE IT WILL GO IF IT IS NOT STOPPED. I, with my attorneys, do not believe this attempt will be successful, for we do not feel that there is a single legal leg to ~~successfully~~ successfully base any deportation move on. I should not be surprised ~~if~~ if those who started these attacks do not find that they have started a power against themselves which will eventually grind them to powder. They cannot successfully fight any movement which has the Power of the Spirit of God behind it, and "PSYCHIANA" happens to be such a Movement. The greatest Spiritual Teacher of all time said--" BUT WHOSO SHALL OFFEND ONE OF THESE LITTLE ONES ~~WHO~~ WHICH BELIEVE IN ME, IT WERE BETTER FOR HIM THAT A MILLSTONE BE HANGED ABOUT HIS NECK, AND THAT HE WERE DROWNED IN THE DEPTHS OF THE SEA"

Sometime ~~this month, or early next month~~, the Review Board in Washington D.C. go over the proceedings against me. They decide whether or not to order deportation. They decide whether or not the charges brought by the Spokane Inspector shall stand, or the warrant be quashed. I feel it is very imperative that one of my Attorneys be there at that hearing. While trusting fully in the Power of the great God-Realm to absolutely protect me, I still feel that I should have the most competent attorney available there.

or finance any further legal expenses.

The legal expenses connected with the past trial, coupled with the fact that I have given quite heavily to the needy and others during the past few years, have left me entirely without funds with which to send one of my Attorneys to Washington. I cannot see the other fellow in need and not help him if I have the means. Money as such means nothing to me. Now--when I need it, I havent got it. My Students owe me now over \$250,000 on Lessons sent to them when they could not pay me for them.

The only thing I can think of to do under these circumstances, is to ask my Students if they will make me a personal loan. ~~Now~~. If they will do so, I will issue to them my personal note for whatever amount they want to let me have, and I will pay 5% interest personally. If anything happens to me, the obligation will be considered Mrs. Robinson's. If this Review Board decides against me, the matter will be immediately thrown into the Courts again, and will be carried to the U.S. Supreme Court if necessary. I dont think there is anything wrong about asking my personal friends and Students for a loan at this time--do you? I have thought this matter over very carefully, and I seem to be led to do this. I know of nothing else to do.

So if you feel that you would like to make me a personal loan, I shall be glad to accept it gratefully I assure you. ~~We have plenty of property here with which to protect the loan, but I want to you trust me in this crisis, and send it to me willingly and freely, if you would like to.~~ Jesus Christ, and many other religious leaders have been persecuted, but the truths they have brought have lived through the ages. So will the truths I am teaching live. NO MAN OR NO HUMAN ORGANIZATION CAN SUCCESSFULLY FIGHT AGAINST THE POWER OF GOD, AND THOSE WHO ORIGINATED THESE ATTACKS WILL FIND THAT OUT.

Whatever amount you decide to loan me, please send it now. It may be only Ten Dollars, or it may be \$1000.00. Immediately on receipt of the money I will send you my personal note bearing 5% interest. ~~But~~ I havent got much time to wait. Lets all pull together in this time of my trial, and, with the help of God, we will put "PSYCHIANA" round the world and never stop until men and women know the TRUTH instead of pagan spperstition and myth.
