Dear Dr. Robinson:-

I have just received a letter from Dr. C. W. Tenney in answer to my last letter to you, and he seems to think that probably I am violating the Federal law on copyright, and advises me to write you personally and explain exactly what I am doing. Having absolute confidence in your sincerity and your desire to spread this teaching to all the world, I am hereby explaining my motives and actions in this respect and I assure you that if I am in any way infringing, word from you to that effect will stop it. Believe me, Dr. Robinson, I will not do anything wrong if I know it.

There are among my friends and acquaintances many poor people who need this teaching, but are absolutely unable to pay the subscription price. These poor people need this teaching more than anyone else, and I am simply trying as best I can to help those who desire to be helped. When some one has been healed and asks me to tell them about this wonderful Power in which you and I trust, how am I going to teach them unless I let them read your Lessons? You cannot tell it to them---they must study it---they must have it before them where they can study and concentrate.

I have inquiries from people who I know are plenty able to subscribe. I tell them what I can and give them your address and advise them to write to you. I NEVER GIVE YOUR LESSONS TO THEM.

When some worthy man I know to be in poor circumstances comes to me and states his desire to learn about the Living God, I hate to turn him down. As I said in my

last letter, it seems too bad that a man must (as the preachers say, "go to hell") because he ain't got the money---and I don't believe that God intended it to be that way.

I would give one person Lesson 1, tell him to keep it two weeks and return it. When he returned it I gave him Lesson 2. I copied the Lessons that in case one should get I would have a duplicate. Each duplicate has the entire headings that are on the original together with a note that they are copied.

I never received one penny for this. I have money offered me for healing but I would not accept it. I make about \$25.00 per week, so you see I'm not lousy with money---just getting by very nicely. But I do want to tell people about the Mighty God-Law and that was the best way I knew. Now, Dr. Robinson, if I am not doing right please let me know and advise me what to do.

Some just read the Lessons, some read them over two or three times, some actually meditate upon them and get results. One man who suffered an attack of sick-headache once a month was healed. He read the Lessons and saw the light. He has frequent vibrations and sees various colors. Now he is healing others. He says that when he gets money enough he is going to subscribe for the Course that he may have it for reference and study.

Now, Dr. Robinson, if there is anything wrong in that, I'M guilty.

I am out in the by-ways and the hedges and am reaching people who otherwise would not be reached. Out in these by-ways and hedges you will find lots of friendship, lots of sympathy, lots of mutual assistance, lots of love; you'll find God there but you will NOT find money. These folks are charitable and free-hearted, they give what they can but they DO NOT HAVE MONEY.

I would like to have the details of your ministerial proposition, although I don't know how I would click as a preacher. I can teach, but I am no orator, have no money, but I have GOD.
