Dear friend Dr. Robinson,

I know that time is of a priceless value to you, therefore excuse me that I trouble you with my own difficulties and affairs, but where it is for Psychiana, it is also of some importance to you. Inclose a letter of a lawyer office which will show you, what that man with who I have break all cooperation in Psychiana is now trying against me. He was a man who always said "beware for the Jews" and now where he is between "The devil and the deep sea" the first thing what he do, is, to run directly for help to an office of Jews case-lawyers with "some" reputation here in town.

You are so friendly to cable me "until further orders you are only representative Psychiana there". So as you see from the letter of his lawyer, he would made a lawsuit against me and claims all Psychiana Lessons, pamphlets, etc, which I have printed, published and paid for, but he said that it is all his own work. But it is not his works but yours, he only translates a great deal of your Lessons for me, as the man who brought Psychiana here in Holland. Thanks God that you have copyrighted those Lessons not only for America but also for Canada; regarding the copyright of the Berner convention I believe surely that you and you only can claim all rights not only here in Holland but in any other country of Europe, and not a man who had do some translating.

I know that you have give me a big support with your last telegram in all attacks against Psychiana affairs, but allow me also in a telegram the authority for the publishing of your Psychiana Course, pamphlets and circulars too. Please will be so kind to cable these matter on my account that A.C. Plagge only has the authority for publishing your Psychiana Course until further orders. Herefor you will oblige me very much. I ask you this for the sake of Psychiana and only to check any lawsuit what that man try to do against me and the Psychiana movement, which I just have settled.

The Psychiana movement is still a big expense to me but I don't care for that, for it is only just in the beginning and I like it there it is a ideal to me and not a business affair. I want to demonstrate with my action nothing else than to keep Psychiana free from any personal egoistical selfishness or as a personly business job. This is a deed which every Psychiana man of some character should do in the same way, who is in my position and situation.


I show you my steadfastness of my feeling in spite of all my difficulties, and don't think there will be any alternation in the future for that Psychiana is the most finest thing to me, and I would make her to the most fundamental school and teaching of my live and that of my countrymen. I am tossed so to and fro by the experiences of the last four months of my life that I have the consequences pretty hard in my own body as a physical

breakdown - this proofed yet my lack in the fast grip of your beautiful Psychiana teaching. But I tell you that I can fight for what I love and respect, that is for Psychiana what I have know and learn in America from you Dr. Robinson who are not only the teacher but the founder of that psychology.

Help me with your psychical power to stay steadfast in your Psychiana principle. My difficulties and expeariances may and should be to me a rene- wing in the power of your teaching.

Latter without any hast I will settle the regulation and agreement which you as a friend and as the founder of Psychiana, for a good fundation in the leading of Psychiana here in Holland and Colonies.

My client reserves for him all right against the pupils of the course, also the charges therefrom and also in the affair of the representation of Dr. Franf B. Robinson in Moscow Idaho.. If you not follows my summons within 3 days after now, you can expect, that lawmeasures will be taken against you.

Client heeft bezwaar, en m.i. terecht, tegen deze wijze van beeindigen en meer bepaaldelijk ook, dat U zich het recht aanmatigt om van zijn geestelijk werk verder gebruik te maken, welk gebruik onrechtmatig is. - Onder reserve van alle rechten, welke client overigens heeft, moet ik U namens hem verzoeken en voorzooveel noodig sommeeren aan mij, als clients gemachtigde, onverwijld uit te leveren alle exemplaren van: a/ 20 lessen der Psychiana-Cursus, b/ brochure "Wie en Wat God werkelijk is". c/ diverse vlugschriften, d/ Propaganda ciculaires. e/ Het Maandblad. Client reserveert zich ook alle rechten ten aanzien van de leerlingen van dezen cursus, alsmede van de opbrengsten daarvan en ook terzake van de vertegenwoordiging van Dr. Frank B. Robinson te Moscow Idaho. Indien U aan mijn sommatie niet binnen 3 dagen gevolg geeft, kunt U verwachten, dat rechtmaatregelen tegen U zullen worden genomen.
