

HISTORY OF THE PLAY

"The Drunkard" or "The Fallen Saved" had its initial curtain in 1843 in the City of New York with P. T. Barnum, self styled "Prince of Humbugs," as the producer. Its first run in his American Museum lasted for over a year and it was repeated at intervals for about seven years in New York, Boston, Philadelphia and other cities. In the early sixties, the script of the play was lost and it was not until 1926 that it was discovered in a trunk stored in an attic in Berkeley, California. Miss Alice Brainerd produced it in that city with great success..

Messrs. Shobe and Bell offered "The Drunkard" in Carmel, California, during the winter of 1931. The reaction of the audience was so good that the producers saw great possibilities in reviving not only the play but also the entire music hall atmosphere, including the OLIO, as you see it here this evening. After almost two years of research the complete Shobe-Bell production made its initial bow to an elite Hollywood audience on July 6, 1933, at the Theatre Mart.

In offering "The Drunkard" for the amusement of Los Angeles audiences, we are re-creating not only the atmosphere of the play itself but also that of the "Music Hall" of that period. Most Halls in the middle fifties operated a bar in the auditorium. Mr. Barnum, a great expounder of temperance, refused to serve whiskey and rum in his Museum. Seated at tables, sipping cool beer, coffee or punch and nibbling at pretzels or sandwiches was a distinct feature to which theatre goers of those days looked forward.

The setting of the stage itself is a practical duplication of the original Barnum sets. Peter Friedrichsen, the designer and builder, has made a careful study of stage design of that period and to him is due the credit for the authenticity of the atmosphere which comes from playing this old melodrama on a stage carefully set to match the play itself. We have, however, modernized the lighting in order to avoid the flickering, shadowy effects of earlier days.

POSTERS IN AUDITORIUM

P. T. Barnum was the forerunner of modern departmentalizing. In his American Museum were housed in addition to his "Moral Lecture Room," (Barnum's method of concealing the name Theatre in order to draw into his pocket the twenty-five cent pieces of those who would not attend a theatre), three floors of curiosities, some real, many faked, but all enjoyed by his thousands of customers. Unfortunately almost none of the exhibits have been preserved. From existing etchings and pictures we have had prepared the posters which are hung on the auditorium walls. They present the most outstanding of the Museum's main attractions.

These club rooms are operated by Theatre Mart, Ltd., a social club organized under the laws of the State of California. The club is supported entirely by dues collected from each member at the rate of \$1.65 for each time the main floor of the club room is used and \$1.10 for each time the second floor of the club room is used between the hours of eight and eleven in the evenings. At the discretion of the Board of Directors guests may be allowed to use the main club rooms during those hours on the same basis as members. Except on special occasions, the dues specified above will entitle members and guests to all refreshments and entertainment provided by the club during the evenings.

Any member of Theatre Mart, Ltd., may secure the exclusive use of the main club rooms between the hours of 10 a.m. and 5 p.m. for teas, musicals, lectures, etc. A nominal charge of \$5.00 is made for such use to cover the extra cost of cleaning, lighting and heating. Members desiring to avail themselves of these privileges can make arrangements with the secretary at his office in the lobby. Other social clubs and educational institutions may, with the approval of the Board of Directors, secure the use of the club rooms on

the same basis as members.


