

RE: Taylor Ranch Television Project Update

Ed,

This note is to let you know about a number of recent successes we've enjoyed with the TR project. Although you and Dean Hendee will receive a complete summary report after I'm finished editing, I wanted to tip you off now.

Taylor Ranch has been cleared for distribution overseas via the United States Information Agency (USIA). I received word yesterday from USIA "Science World" producer Robert Sibley that a 4:45 segment featuring TR that I sent them in mid-October has been accepted! USIA (the official propaganda arm of the U.S. government) will translate my script into five different languages sometime in late January '88. (English, French, Spanish, Portuguese, and Arabic)

USIA claims to transmit, via satellite, to 90 countries worldwide, with a potential viewership of over 100 million people.

In addition, I'm negotiating with Fuji-TV (the national TV network of Japan) to possibly air the 30-minute IEPBS special in that country. They have already given tacit approval (sight unseen!) to air a 3-7 minute segment on their Japanese-language news program in New York. And officials at the UI now are urging me to attempt to air a TR piece in the Soviet Union. We've already identified the appropriate USSR official in New York, although I'm currently having trouble reaching him. I'll keep you informed. Thanks for all your help.
