Taylor Ranch deed and grazing permits

I've given Nancy a copy of the warranty deed for Taylor Ranch and property map for your files. Except for water rights and ditch rights-of-ways, there's no mention in the deed of grazing rights, mining rights, etc. I've reviewed the records I have concerning USFS grazing permits for the field station. From the early 1970's through 1982, the Big Creek District (now Krassel District) granted the field station a special use grazing permit for 4 head on the south side of Big Creek adjacent to the field station for the entire year. In 1990, a short term permit was granted during the period the National Guard was moving the Lanham cabin to the field station. These all were special use permits with specific periods and stock limits for stock used for domestic purposes of inholdings. So there is no allotment attached to the field station that I can discover. So I don't think we need worry about losing any rights by not grazing stock off the field station or proving up on any gold mines.
