Have taken pictures of monument and will send some of them later. They will show the kind of country I have to work in.

In figuring up this bill I've tried to be fair and reasonable. I always try to be as patriotic as the next one.

I made the trip to McCall personally, as I wanted to be sure the stone was in good condition. Also that the cement was in the right condition. It being a very busy time of the year, I was almost forced to do the work by myself. With the kind and able assistance of Mr. Harry Shellworth (one of the head men of Boise Payette Lumber Co.) I was able to put the marble stone in place and cement it there. At any time I will be glad to refer you to Mr. Shellworth, Boise, Idaho, concerning this monument.

As far as the cement is concerned I may use it. But if for any reason that it may be wanted, I am taking good care of same. I shall make it a point to look the monument over in the spring. It certainly is a great landmark.

2. Colonel Brown has given freely both of his time and of his labor in securing a proper recognition of this Indian Campaign of the Second Infantry and in causing a suitable monument to be erected in memory of Harry Eagan, formerly a private Company C, 2nd Infantry, who died on the field of battle. However, Colonel Brown, before concluding this most worthy undertaking, has given the Regiment an opportunity to participate therein to the extent of contributing the additional cost to the Government resulting from the cost of inscribing a proper record on the monument of Private Eagan.

3. a. In order that the amount now due for the extra lettering on the headstone of Private Eagan, may be promptly paid, every member of this regiment, both enlisted and commissioned, is requested to contribute at once five cents for this worthy purpose.

b. Contributions of officers will be delivered to the Adjutant.

c. Contributions from enlisted men will be turned over to their respective company commanders who will deliver same to the Adjutant.

"Memorandum: For General Hines:

Plans have been completed for erection of headstone which will serve the double purpose of marking the grave of Private Harry Eagam, Company C, 2nd Infantry, and the site of the engagement of August 20th, 1879, on Big Creek, Idaho, where he was killed.

This monument when erected will probably be the most remote from civilization of any similar monument in the United States, for even now after shipment to McCall on Payette Lake, Idaho, it must be transported some seventy miles by wagon to Edwardsburg and nearly forty miles by pack mule to its destination at Soldier Bar.

This expense as well as the cost of erection of headstone in a five foot pile of boulders will be met by the Quartermaster Corps.

In order that the monument should serve to mark the site of the engagement as well as the man's grave, extra lettering was necessary-the extra cost being \$23.58, the payment of which I have personally guaranteed. It is thought that members of Company C, 2nd Infantry, will be willing to share this expense, and if they will contribute \$20.00 and send it to Major R. P. Harbold, Q. M. C., U. S. Army, Chief of Cemetery Division, Q.M.G.O., I will take care of the remaining \$3.58.

Major Harbold, Chief Cemetery Div. Q.M.G.O., says this is A. K. The former 2nd Lt. Co. C, 2nd Inf., now Chief of Staff, U. S. Army, authorizes me to say that this is a good move and worthy of the cooperation of his old company.

There are three officers, one ex-soldier and one civilian still living who were present when Pvt Eagan was buried. The civilian is Mr. David Lewis who was a packer with the train of Co. C, 2d Inf., and who now lives about two miles above Soldier Bar and can point out the exact spot where the man was buried. In placing a headstone over the grave it was thought appropriate that the lettering should show not only the man's name, rank and etc., but that it should show also the site of the engagement and the troops taking part in it.

I proceeded on these lines and conferred with the Chief of Staff U. S. A., who was interested as having later joined that company as a 2nd Lieutenant.

The entire matter received his approval and I asked Maj. R. P. Harbold, Q. M.C.-In Charge Cemeteryal Div. Q. M. G. O., to have the stone cut accordingly and that I would be personally responsible for such extra expense as might be incurred.

A blue print showing the stone and its lettering in full size, and the 5 foot mound of boulders laid in cement, on reduced scale, together with carbon copies of correspondence pertaining thereto, are all enclosed herewith.-the entire matter having been submitted yesterday to General Hines and received his approval. (See carbon copy "Memo. of May 27, 1925 enclosed")

As organization commanders are enjoined by G. O. # 1, A. G. O. Jan. 4, 1905 to keep an up-to-date history of their organizations I am enclosing (hoping that it may be of interest) a map of the immediate theatre of Operations of 1879 and a brief outline sketch of this campaign which appears in this month's issue of "Winners of the West".

I have considerable additional data relative to this campaign which I have secured from notes, diaries and old War Department Records, and during the coming summer, at the request of the Historical Society of Idaho, expect to prepare for publication a somewhat more detailed account of the operations of 1879.

It is assumed that you have a copy of Major C. B. Hardin's account of this campaign published in the July-Aug, 1910 issue of the Journal Military Service Institution and the Annual Report Comdg Gen. Dept. of Columbia, Sept. 10, 1879.

As I have served with the 2d Infantry in the 1878 & 9 Campaigns and again at Camp Stotsenburg about 1907, I have on this account less hesitancy in presenting this matter for consideration.

Having been one of the participants in the Sheepeater Indian Campaign in Middle Idaho 1879, I have recently interested myself in having this recognized by the War Department as a regular Indian Campaign, and on Feb. 27th, 1925, a Memorandum, of which the following is an extract, was published from the A. G. O.

A. R. 600-65 Changed as follows:-

6. Service required.

* * * * b. Indian Campaign Medal.

Dear Sir:

At the suggestion of Colonel W.C. Brown, U.S. Army, Retired, a headstone has been prepared for the grave of Private Harry Eagan, Co. C, 2nd U.S. Infantry, who was killed August 20, 1877 during an attack by Shoshone Indians on rear guards and pack trains of Companies "C", 2nd Infantry, and "G" and "H", 1st Cavalry. This soldier is buried at Soldier Bay, and it is understood that you know the location of the grave.

The Quartermaster General desires that you be communicated with, with a view to ascertaining whether you will receive the headstone if it is shipped to you, and make the necessary arrangements for its transportation to the place of burial and for its erection at the grave. It is understood that shipment would be made to McCall (near Big Payette Lake), Valley County, Idaho; thence by wagon 70 miles to Edwardsburg by way of Warren; thence by pack mule 20 miles to Soldier Bay. If satisfactory, the stone will be shipped to McCall and notice of shipment sent to you at Clover, so that you may go to McCall or make arrangements for its removal to the grave.

The Government will pay the expense of hauling the stone by wagon and by pack mule and for its erection at the grave. It is preferred that you act for the Government and pay the man who hauls the stone by wagon or pack mule and sets it up.

The request to do this work is not made so much on account of any small profit or pay which may be gotten for the work, but it is understood that you would undertake the work through patriotic interest, and thus assist the Government in placing a monument at this soldier's grave.

In view of the assurances of Colonel Brown, that you will undertake the job, the stone has been ordered to be shipped to you at McCall, and notice will be sent to you at Clover. In the meantime you can make the arrangements for its hauling and setting up. This stone should be set up on a mound as shown on the enclosed blueprint, the mound to consist

SPECIFICATION FOR THE SETTING OF A HEADSTONE TO
MARK THE GRAVE OF PRIVATE HARRY EAGAN, BURIED IN AN
ISOLATED PLACE IN IDAHO.

1. The headstone itself will be of white marble of the dimensions shown on accompanying drawing No. 6591-100. It is to be set in a conical base of cement and boulders, as shown on drawing. This base should be 8'-0" across at the ground level and it should be carried below the surface of the ground about 18 inches. (See sketch on Drawing.)

2. Dig a pit about 18 inches deep and 8 feet across and finish the bottom level. Fill this pit about one foot deep with boulders, or stone not larger than can be lifted and carried by one man. These should be set in place close together so that they will not move round. Then build up on this loose boulders fitted together as well as possible to a height about a foot less than the outside surface shown in the drawing for the completed monument and setting the stone plumb in the top. Then cover the outside with smaller stones cemented between and in place sloping off the cement joints so that the water will run off and not collect.

3. The outside joints and crevices of the conical base should be thoroughly filled with the mortar and should be finished about as shown on the drawing. The cement surface immediately around the marble headstone should be trowelled smooth and slope away from the stone so that the water will run off quickly.

4. Twelve bags of cement will be necessary to make the mortar and this should be mixed with sand, or fine gravel. The mortar should be mixed only as fast as it can be used, as it will set in a short time. It should be made by mixing one bucket of the cement with three buckets of sand, or fine gravel; these should be mixed thoroughly while dry and then enough water added to make a stiff mud.




