Thanks for sending my shoes! I hope you folks enjoyed the holidays, and that your remaining pets are hanging in there.

I spoke with Terry Bowyer, as well as Richard Inouye (interim dept. head and head of graduate research), Dave Delehanty, and Chuck Peterson about the DeVlieg Graduate Research Assistantship. Not surprisingly, they were excited at the news. As I stated during our visit, my main concern is that we make this first go-round a success so the assistantship can have the effect you and Janet have envisioned. It was not my intention to commandeer these resources. That said, Terry and Richard both suggested that I would actually be the person best situated to make this work well the first time. I have a research plan (related to the land-water ecosystem connections we had discussed), I have the matching funds and equipment, I have the time myself, and I now have several very well-qualified student applicants (including Chris McDaniel) who could start this summer. In addition, I have been communicating with Jeff Braatne at UI, who has spoken with Janet and plans to submit a proposal for work that would be collaborative and complementary.

As I told Janet when we talked by phone several days ago, I have been working hard to submit a proposal to NSF (just turned in this morning) that if funded might also involve work in Big Creek. In addition, I am getting ready for teaching this semester. However, I will get you a proposal to read by the end of the month. Of course, the decision rests with you folks. I will be interviewing my top student candidates over the next few weeks, but will inform them that the funding is still pending.

Also, as we discussed, I would like to bring my graduate stream ecology class into Taylor Ranch later this spring. I have 5 masters students enrolled at present. Jeff Braatne has also offered to come in and assist with this field trip. You mentioned that there may be travel grants I could apply for to help defray flight costs for the students. It would be great if you could let me know how I should proceed on that front.

This spring and summer hold exciting prospects. I'm looking forward to it!
