I have excluded weekend and overnight trips.

Having spit all of that out and now scanning down this green flier I have come to the part that asks for me to summarize why I am interested in this position. Well, two reasons seem to have popped simultaneously into my oversized underutilized Texas noggin. First and least important after having reviewed my financial assets, it is obvious even to me with my limited cryptic financial savvy that any monies earned this summer would be helpful for the fall semester. However, second and most important is the experience itself and; believe me, after workfor an oil company for sixteen plus years with the past four being in a management position I know the value of experience.
