

This should be a very quick and easy letter to write. It isn't. And, I'm not quite sure why this has been so. I have started and quit this letter several times. There have been lots of interruptions, distractions. If I would stick with the logistical facts / questions and dispense with the rhetorical hyperbole certainly this would go quick. However. — Temporarily I have a mind to purge, a soul to search. (Methinks there is some sort of puny and personal amorphous irony at work here! If there is I need to flush it from its cover). The point is — I know I'm rambling and you know I'm rambling. So, please excuse me my whimsies; they're therapeutic.

It seems a gross impropriety to attach significance to one's own difficulties when set against the backdrop of global uncertainty. Yet I cannot help but feel some measure of anxiety about my impending change in life. Do not misunderstand me. I am not having second thoughts about coming to school there. I am as sure as I can be that, for now, Moscow Idaho is where I want to be. The University of Idaho is the school I want to attend and Wildlife Biology is the degree I want to pursue. The problem I am having is what to do with my accumulated personal effects? I have some
