I would like to get the PL's and any scientists interested together to help me develop detailed plans for the IWGCRP. As I see it we will have approximately \$200,000 as an operating budget. I would like to spend this on a combination of things including workshops to help identify researchable needs & priorities in certain ecosystems, cooperative opportunities, etc; initiation of assessments or at least identification of the need for assessments, required quality, etc.; supplemental funding to RWU's to enhance GC related process research and/or cooperative extramural research.
I am planning a 2 day workshop format with primarily internal people from both Stations (all PL's & scientists from funded projects invited all others welcome), one or 2 outside speakers (inc someone from NCAR to talk about climate change scenarios), a few selected other agencies BLM, NPS, ARS, USGS, etc.
We are just starting to look into hotels, in the Denver, near airport vicinity. Does this sound appropriate?

The Intermountain Research Station and the Rocky Mountain Forest and Range Experiment Station have recently established the Interior West Global Change Research Program. The draft Program Charter is enclosed which explains the objectives and scope of the program.

In order to develop a strategy to achieve the ambitious goals of the Interior West Global Change Research Program, we are planning a workshop on March 12 and 13. The workshop will be held in Fort Collins in order to take advantage of a number of scientists attending the Symposium on Biodiversity of the Rocky Mountains being held at Colorado State University the same week. Our meeting will begin at 8 a.m. on March 12 and be completed by 5 p.m. on March 13.

This meeting will be held at the University Park Holiday Inn, 425 W. Prospect Rd. Ft. Collins, CO (303-482-2626). The Airport Express (303-482-0505) runs roughly hourly between the hotel and Denver Stapleton Airport. Please reserve rooms at the hotel by February 15. We have a block of room reserved.

We hope all of you will be able to attend. Individuals in both Stations who are either working on or interested in global change research are also welcome. Cooperators are invited, however, our intent is to deal with RWU interests and capabilities. Following this meeting, I plan to hold another to expand our cooperative connections with other researchers on global change in the interior west.

The objectives of the workshop are:

- (1) Review RWU and cooperators current research and its planned contributions to the IWGCRP.
- (3) Identify needs for IWGCRP work in assessments and modeling.
- (2) Identify opportunities for RWU's and cooperators to contribute to the FSGCRP modeling effort.
- (4) Identify opportunities for RWU's to contribute to assessments.
- (5) Draft a strategic plan to aid the IWGCRP to accomplish its objectives in core research, assessments and modeling.

We will send an agenda shortly, but please plan to come prepared to provide a very brief (5-10 min.) overview of Project Global Change research. Otherwise formal presentations will be held to a minimum.
