To All Technical Review Panel Members:

It was gratifying to find that you all were willing to take on the task of reviewing our planning process for the Gospel-Hump. I had anticipated that it would be difficult to gather together a group such as yours, for I realized you would have many other concerns and commitments.

We think we can obtain sufficient review in two meetings. However, we will arrange others if, after our initial meeting, you feel they are necessary. The dates of the scheduled meetings have been set for August 20 and September 17. We will meet here in Grangeville in my office at 9 a.m.

At our first meeting, it is our intent to provide you with our study plan, role statements, papers concerning a resource overview, our present technical state, fiscal policy, socio-economic variables, relevant legal parameters, and selection criteria we will apply to potential alternatives.

We will update any changes and present feasible alternatives during our September 17 meeting. It is likely that your critique may expand this meeting or require additional meetings.

If you cannot attend either of these first meetings, we will furnish you all the data presented and minutes of the meeting. You could then, perhaps, comment on that basis.

The Nezperce National Forest is preparing a land use plan and environmental statement for the Gospel-Hump Planning Unit.

The environmental and emotional sensitivity of this general area and the intense interest expressed by the public in our proposed management activities for this unit necessitate that we put forth a major effort to complete this plan. As part of our planning effort, I believe our process and accomplishments should be periodically reviewed and critiqued by a group of professional individuals functioning as a Technical Review Panel. We would like to invite you to serve on this panel. We are also extending this invitation to those listed on the enclosed list.

The Technical Review Panel will receive periodic briefings, review draft documents as they are being prepared, and offer comments to improve our planning efforts, especially in the areas of the member's technical expertise.

Formal or written reports from the Panel will not be necessary. The impact on your time will be kept to a minimum. As of now, reviews are tentatively planned in Grangeville on August 12, October 15, and November 20. A definite meeting schedule will be sent to all who agree to participate on the Panel. Each meeting should last no more than four hours.

Because of the critical nature of this project, it is important that I know whether or not you will be able to help us with this task as soon as possible. In addition, any suggestions that you might have for improving our approach would be appreciated.
