WRC Logo:

Hendee reported on a meeting attended with Yeo, Krumpe and Vice-President Harry Peterson and staff from the communications office to discuss design of a Wilderness Research Center logo. Subsequently, two additional meetings have been held and it may be possible to share designs prepared by UI communications at the next WRC Advisory Committee Meeting. Hendee, Krumpe, and Yeo contributed ideas in great detail about symbolism surrounding the WRC (rivers, peaks, eagles, salmon) but the artists have prevailed insisting on a sleek corporate design to appear on all WRC materials in order to acquire visual recognition—but with plenty of opportunity for t-shirts, hats, posters, notecards, etc. to contain more detail of the WRC vision/image. The theme for the logo and potentially for the WRC is "Wilderness-the World's Living Laboratory". We should have a lively session discussing the logo proposal. Keep your minds open. 

Subject: Strengthening focus for the '92-'93 academic year.

I appreciate the work Jeff did on the annual report, and for this year. I suggest we go with the last edited version I have enclosed, appended with my letter to Dr. Bell. I favor limited distribution for now until we can meet and discuss how to further broaden UI involvement.

The past two years we have consolidated management to accomplish some changes (hiring Jeff, the Lanham addition, WRC directorship) but the future of WRC and Taylor Ranch depend on building an expanded program with broader UI support and involvement. We may not survive, much less thrive, without it. I would like the three of us to meet and consider how to move in that direction and make it next year's goal to progress in that direction. We need more shared leadership. The composition of an advisory committee and charter for its responsibilities is a key, and a very well planned convening of that group is essential to address issues. CFWR domination of the WRC and Taylor Ranch is a potential weakness, but I don't know who outside of the college to involve in planning expanded involvement. Continued progress toward achieving potential of the WRC and Taylor Ranch, including shared leadership and removing a lingering stigma from long past, will be essential to getting UI support for WRC and Taylor Ranch.

Nancy will plan a meeting among the three of us. In the meantime I will chat with each of you as occasions permit, and maybe talk with some other individuals.
