Basic Data for Land Classification State Summary*

FORTY-FOUR county pamphlets have been mimeographed to give detailed county maps and figures. It seems desirable to add county figures together to give a state summary. Only a part of these data given in the county pamphlets can be so summarized. Four tables are here given, namely:

- 1.—Complete ownership inventory of Idaho lands.
- 2.—Complete inventory by type of owner of all privately owned land in Idaho outside corporate limits; also, agricultural lands classified by tenure.
- 3.—Total acres of privately owned land by groups of counties delinquent, respectively, in January, 1934; January, 1935; January, 1936 and percentage of that delinquency originating by years 1928 to 1935.
- 4.—Acres of privately owned land with taxes paid and delinquent by counties for recent years.

It has not been possible to make state maps of the information contained on the six maps published in the county pamphlets. The state map would be far too small in scale to show the details desired. If maps of the state showing the location of agricultural lands, irrigated lands, forest lands, and so forth, are desired, these can be found in Idaho Agricultural Experiment Station Bulletins 207 and 208, *Types of Farming in Idaho*.

The data given in this bulletin have been collected from county records and from individual assessors. The accuracy of the data is limited by the source of the information, particularly the acreages and percentages of the various grades of farm land and the type of tenure on individual farms. Ownership and tax delinquency is a matter of record from the tax books.

These figures give the tax status only for the years indicated. Tax delinquency shifts rather rapidly with time, depending upon farm prosperity or depression. Ownership of some land parcels shifts from year to year, but the percentage of the land in different private ownership classifications does not change much. Neither does the amount of publicly owned land vary greatly from year to year. There are a few exceptions during recent years where reclamation projects have been developed.

Table 1 gives the assessor's classification of privately owned lands, while federal lands, state lands, county and municipal lands were obtained from county records and agencies engaged in their administration. These figures are given by counties and by state totals. In all, there are 53,319,679 acres of land in all counties. Of this land, 13,706,966 acres were privately owned, 35,514,184 acres were Federal lands, 3,335,408 acres

were State lands, and 15,881 acres lay in municipalities or were classified as "Other" or "Miscellaneous" land.

Each class of land ownership has been divided into sub-classes, except County and Municipal lands. Of particular interest is the division of agricultural land or plow land into "irrigated" and "dry." There are also "grazing" land and "waste" land. Of non-agricultural lands, there are "mining," "cut-over," and "timber" land and other miscellaneous land.

Of Federal land, there are parks, national forests, stock drives, rivers, lakes, and reservoirs, Indian lands, public domain, homestead unpatented entries, and national monuments. National forests and public domain covered about 90 per cent of all Federal lands.

State lands consist of school lands, parks, contract-for-sale lands and other miscellaneous lands. School lands contained 1,936,332 acres and other State lands, mostly timber and grazing land, equalled 1,168,884 acres. Contract-for-sale lands, mostly dry farm lands, which had been sold to farmers on time payments, equalled 223,334 acres. State parks contained 6,858 acres.

County lands held mostly for tax sale were nearly three-fourths of a million acres (747,240 acres). Municipal lands equalled 15,281 acres. All other land classes contained only 6,000 acres.

In percentages, Federally owned lands equalled 66.6 per cent, State lands 6.3 per cent, County lands 1.4 per cent, Municipal lands .03 per cent, and Other lands .01 per cent. Privately owned lands were 25.7 per cent of the state area. For sub-classifications, Table 1 should be consulted.

Privately owned land is classified and inventoried in Table 2. Farm lands have been classified into "owner-operated" and "non-owner-operated." There is also the classification "idle," which, when applied to farm lands, means unused lands. Another type of farm land is classed as "company-credit institution" land. This is mostly "mortgage foreclosed" land. "Company other" is all land owned by all other corporations. This type of land includes timber and cut-over lands, some farm lands, mining property and miscellaneous lands. All land within corporate limits (nearly all of which is privately owned land) equalled 96,957 acres. Other lands not in the above classes equalled 103,571 acres in private ownership.

Table 3 gives a record of tax delinquency on privately owned lands. The growth of extreme delinquency of rural lands was gradual from 1928 up to 1931. Delinquency became accelerated in 1932 and 1933, with some decline in the rate of increase in 1934. In 1935 and later, the decline in annual increments to the tax delinquent list was rapid and progressive. Many delinquencies were paid off which reduced the total delinquency. For these data, counties have been grouped according to the year in which the tax delinquent status was recorded. This makes three groups for the years 1934, 1935, and 1936, respectively. In each case, the records were taken as of January that year. Since the status of delinquency in January of each year was recorded, these figures do not include delinquencies which had arisen from 1928 to that year and which had been paid prior to these dates.

The loads of delinquency recorded for these years arose over a period from 1928 to that particular year and a small amount prior to 1928, which is shown in Table 3. It can be observed that in the group of counties listed

for January, 1934 the origin of delinquencies in the early years, 1928 to 1930, were larger than for the groups of counties listed for January, 1935 and 1936. This is to be expected because much tax delinquency was reduced beginning in 1934 and continuing in 1935. Certain legislation making redemption easier made the payment of taxes for the latest three years less urgent than for the earlier year. In general, tax delinquency was coincident with the great depression. However, even in 1935 and 1936, the acreage yet delinquent was large.

A record of the acreages of all rural lands which were delinquent or paid in individual counties and groups of counties is given in Table 4. The same years and grouping as found in Table 3 are used.

For the group of counties for which the delinquency status of January, 1934 is recorded, delinquent irrigated crop acreages equalled 63 per cent of all irrigated crop land. Dry crop land showed about the same proportion as did grazing land. However, the four counties grouped in January, 1935 had not quite one-third of the irrigated crop land delinquent and about the same for dry crop and grazing land. For the January, 1936 group, irrigated crop lands were only about 30 per cent delinquent. Dry crop lands were about 20 per cent delinquent. Table 3 illustrates how delinquent taxes were being paid off during 1933, 1934, and 1935.

It is hoped that this bulletin, along with the 44 county pamphlets will be of statistical service to many individuals and agencies, both private, and governmental.
